11/24/21 – Spotted 25 sx Class H cement on top of CIBP to 8110’.

11/29/21 – Tagged TOC 8110’. Joe Salcido with BLM was good with tag. Spotted a 25 sx Class H cement plug from 8137’-7911’ calc TOC. No tag required. Spotted a 25 sx Class H cement plug from 7635’-7409’ calc TOC. No tag required. Spotted a 25 sx Class C cement plug from 6363’-6111’ calc TOC. No tag required. Spotted a 25 sx Class C cement plug from 5128’-4876’ calc TOC. No tag required. Spotted a 25 sx Class C cement plug from 3760’-3508’ calc TOC. No tag required. Perforated at 3545’. Let Joe Salcido with BLM know we pressured up to 500 psi, held 10 min. Spotted a 35 sx Class C cement plug from 3595’-3193’, tagged. Joe Salcido with BLM was on location and witnessed tag.
