Run 10.75 inch 45.5 lb J55 surface casing to 1292 ft. Pump 20 bbls fresh water and 40 bbls gel spacer, followed by 450 sks of 13.5 ppg lead cmt, 150 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls fresh water and 90 bbls brine. 105 bbls of cement returned back to surface. Pressure test casing to 1600 PSI for 30 minutes, good test. 11/13/2021 Spudded well.
