Ran 4 joints 8-5/8", 24#/ft, J-55 casing to 169' GL. Float collar @ 127'. Centralizers on joints 2 & 3. Cemented w/160 sks Class G cement (188 cu ft) w/1% CaCl2, 0.25 lb/sk celloflake, 0.2% CD-2 (15.8#/gal, 1.18 cu ft/sk, 5 gps mix). Dropped plug. Displaced w/8 bbls water. Circulated 15 bbls cement to surface. Bumped plug w/300 psi. Plug on bottom @ 9:00 AM 10/24/2021. WOC 10 hrs. RU Wilson Services for testing @ 10:00 PM 10/24/2021. Tested surface casing, BOP, choke manifold, and annular for 30 minutes to 800 psi high and 200 psi low. All tests passed.
