2/7/2022: Test BOPS. Drill 12.25 intermediate hole to 5350 ft.

2/8/2022: Run 9.625 inch 40.00 lb J-55 intermediate casing to 5325 ft. Pump 20 bbls chem wash, 20 bbls vis water, followed by 712 sks of 10.5 ppg lead cmt, 333 sks of 14.8 ppg tail cmt. Drop plug and displace with 400 bbls of cut brine. 200 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

2/9/2022: Drill 8.75 inch production hole to 8884 ft then switch to 6.75 inch to 19817 ft

2/16/2022: Run 5.5 inch 20 lb P-110 production casing to 19801 ft MD. Pump 20 bbls chem wash, 20 bbls vis water, then 337 sks of 10.5 ppg lead and 1642 sks of 13.2 ppg tail cmt. Drop plug and displace with 00 bbls sugar water, 427 bbls brine. 0 bbls returned to surface. Est TOC at 3750 ft.
