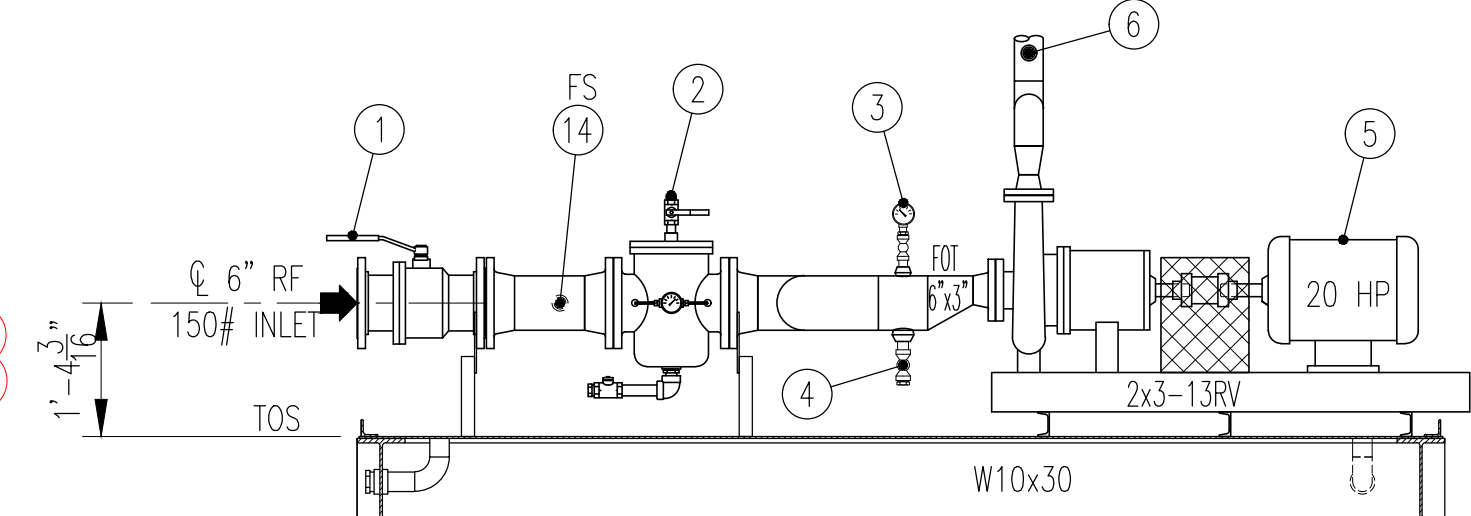
PANEL RACK DETAIL- FRONT SIDE
