3/7/22 – MIRU and NU BOP. RIH with GR/JB to 3020'. Set a CIBP at 2990'.

3/8/22 – RIH and tagged CIBP at 2982'. Pressured up to 500 psi, pressure fell back to 200 psi. Called Omar with BLM-Carlsbad and decision was made to add 10 sx cement to plug. Spotted 35 sx Class C cement on top of CIBP to 2796', tagged.

3/9/22 – Perforated at 1883'. Pressured up to 600 psi, no injection. Spotted a 35 sx Class C cement plug from 1941'-1722', tagged. Omar with BLM was on location to witness tag. Perforated at 910'. Established injection rate, no circulation. Squeezed with 70 sx Class C cement from 910'-670', tagged.

3/10/22 – Perforated at 450'. Squeezed with 65 sx Class C cement from 450'-219', tagged. Omar with BLM on location to witness tag. Perforated at 150'. Squeezed with 50 sx Class C cement at 150' and circulated up to surface. Omar with BLM on location to witness cement to surface and all work was reported to Omar by text when not on location.

3/15/22 - Cut off wellhead. Installed above ground dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
