Actual Procedure: Franklin Mountain Energy, LLC (FME), Operator of the above captioned well, respectfully submits the below drilling operations notice: Drilled 2nd intermediate 8.75" hole and land curve at 12,140' TD KB. Condition hole. RIH w/ 7.625" 29.7 lb/ft, HCP-110 intermediate casing as follows: 1 float shoe - 2.70', 1-jt 41.33', 1-float collar 2.85', 267-jts (10,927.84') landed @ 12,129.29'. Cemented 7.625" casing as follows: fill lines & pressure test to 4,000psi. - ok. Mix and pump 40 bbls mud push @ 9.00 ppg, mix & pump lead cement 305 bbls @ 9.09 ppg, mix & pump 80 bbls tail cement @ 14.80 ppg. Shut down and drop plug. Displace plug with 555 bbls water. Plug bumped on calculated displacement (fcp = 2,600 psi) with 500 psi over final circulating pressure (3,100 psi). Held pressure on floats for 5 min. Bleed back 6 bbls. Floats held. Received 150 bbls cement returns to surface. Good cement.
