OXY USA INC requests approval to add Red Tank; Bone Spring (51683) Pool to existing well Covington A Federal #018 (lease NMNM02379) in PLC 767A. Red Tank; Bone Spring is currently an approved pool in NMNM02379 in PLC 767A. The C-102 for Red Tank; Bone Spring is attached. Downhole commingling of Red Tank; Bone Spring and currently approved pool Red Tank; Delaware, West (51689) in Covington A Federal #018 has been approved per DHC 58.

The facilities described in PLC 767A are unchanged – each facility has a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. Any commingling of wells upstream of these meters has been approved according to the Commingling Orders for each individual facility.

This request is for gas production only. Oil production will be handled through an amendment to PLC-727B.

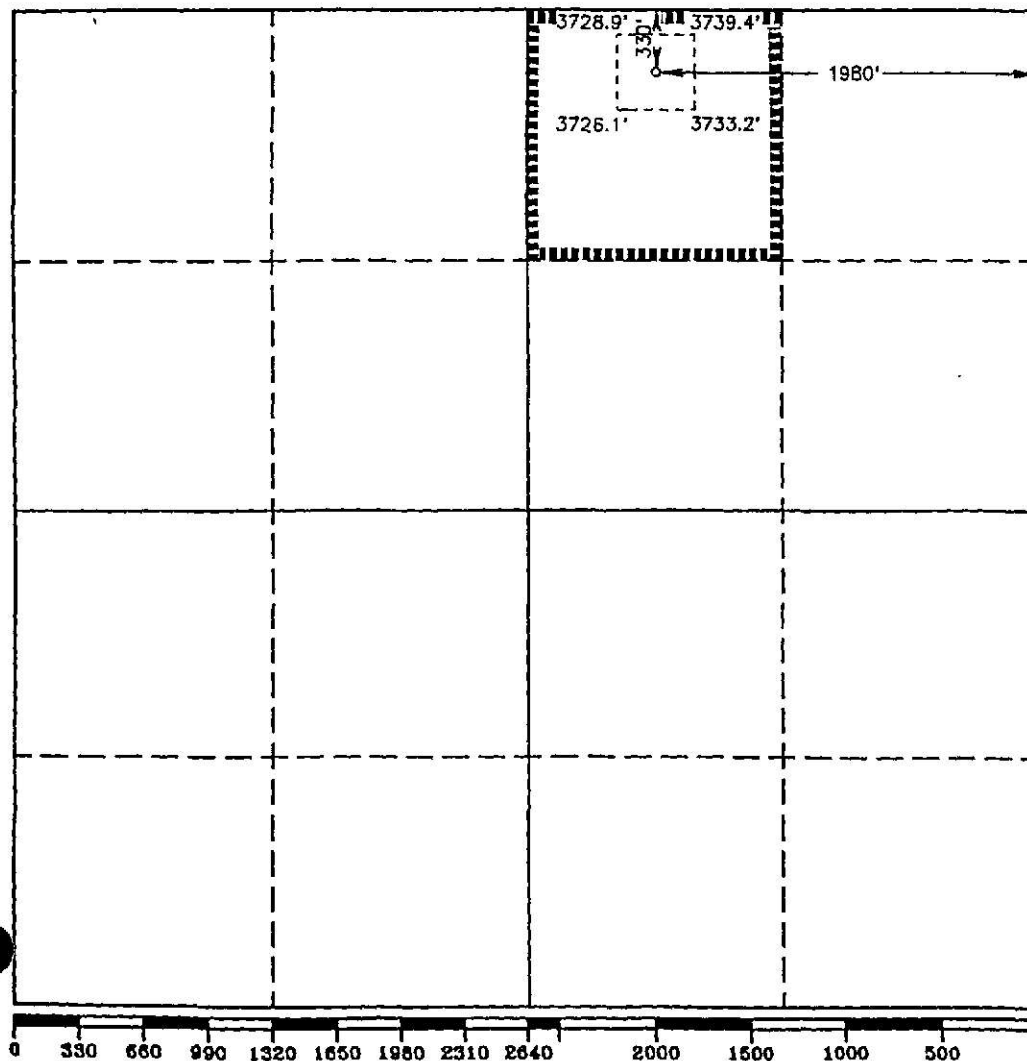
