3/10/22 – MIRU and NU BOP. RIH with bit and scraper and tagged up at 9075'. Good tag. Spoke with Terry Cartwright with BLM-Carlsbad concerning cement on top of composite plug, approval given to dump bail 35' cement on top of composite plug.

3/14/22 - Dump bailed 8 sx Class H cement on top of composite plug at 9150'-9106' calc TOC.

3/15/22 - Tagged TOC 9110'. Texted Terry Cartwright with BLM and let him know where we tagged. Set a CIBP at 8790'. Pressured up to 500 psi. Either have a leak or hole in casing. Talked to Terry Cartwright with BLM and decided to spot 45 sx Class H cement on top of CIBP. Spotted 45 sx Class H cement on top of CIBP to 8692', tagged. Terry Cartwright witnessed tag.


