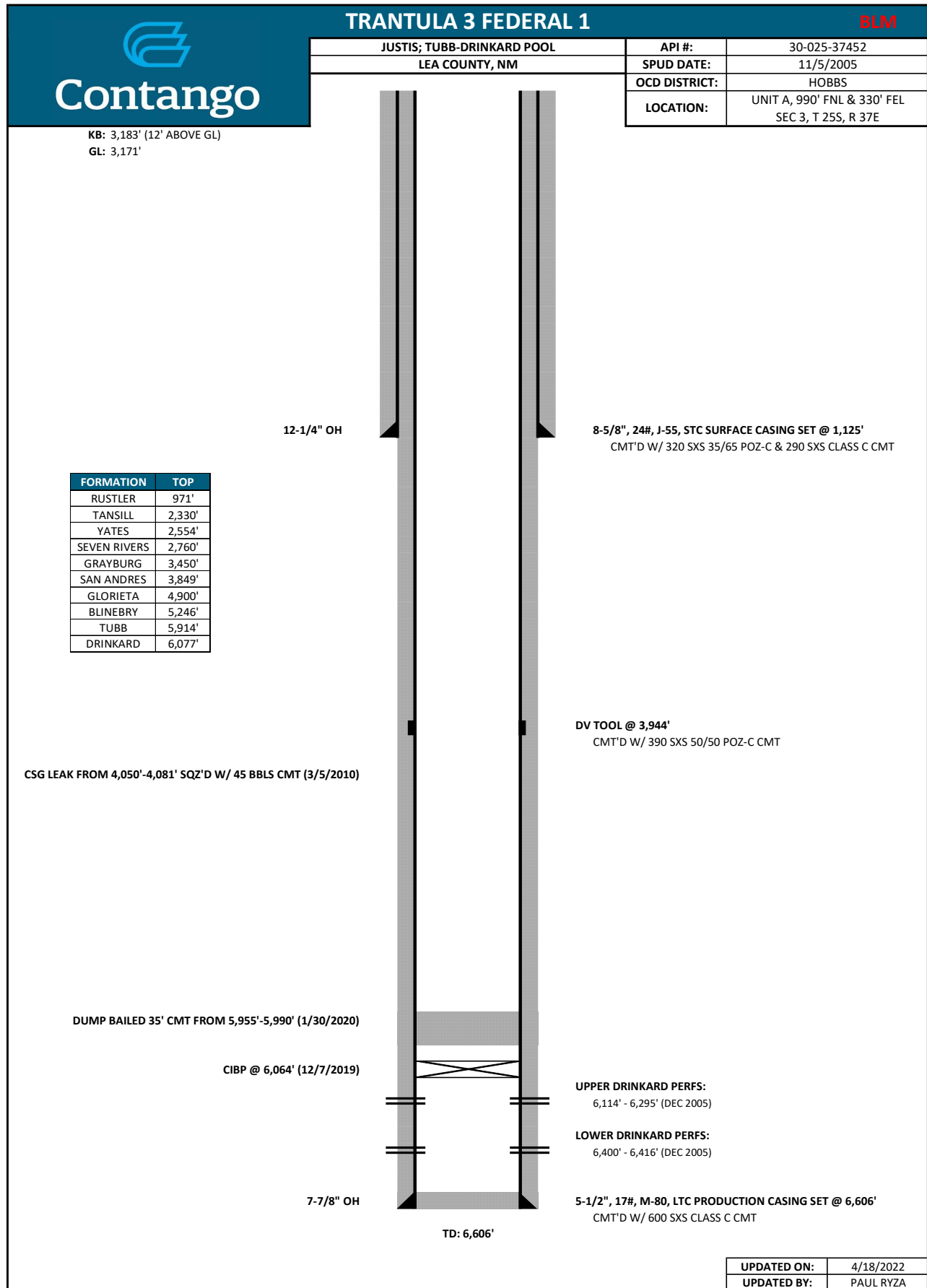

3. Spot 30 sxs cmt from 3,759' - 3,994', WOC & tag (DV Tool & San Andres).
4. Spot 20 sxs cmt from 2,484' - 2,604', WOC & tag (Yates).
5. Perf @ 1,175', circ/sqz 85 sxs cmt from 911' - 1,175', WOC & tag (8-5/8" csg shoe & Rustler).
6. Perf @ 200', circ/sqz 65 sxs cmt from 200' to surface.
7. Cut off wellhead, verify cmt to surface, weld on dry hole marker.

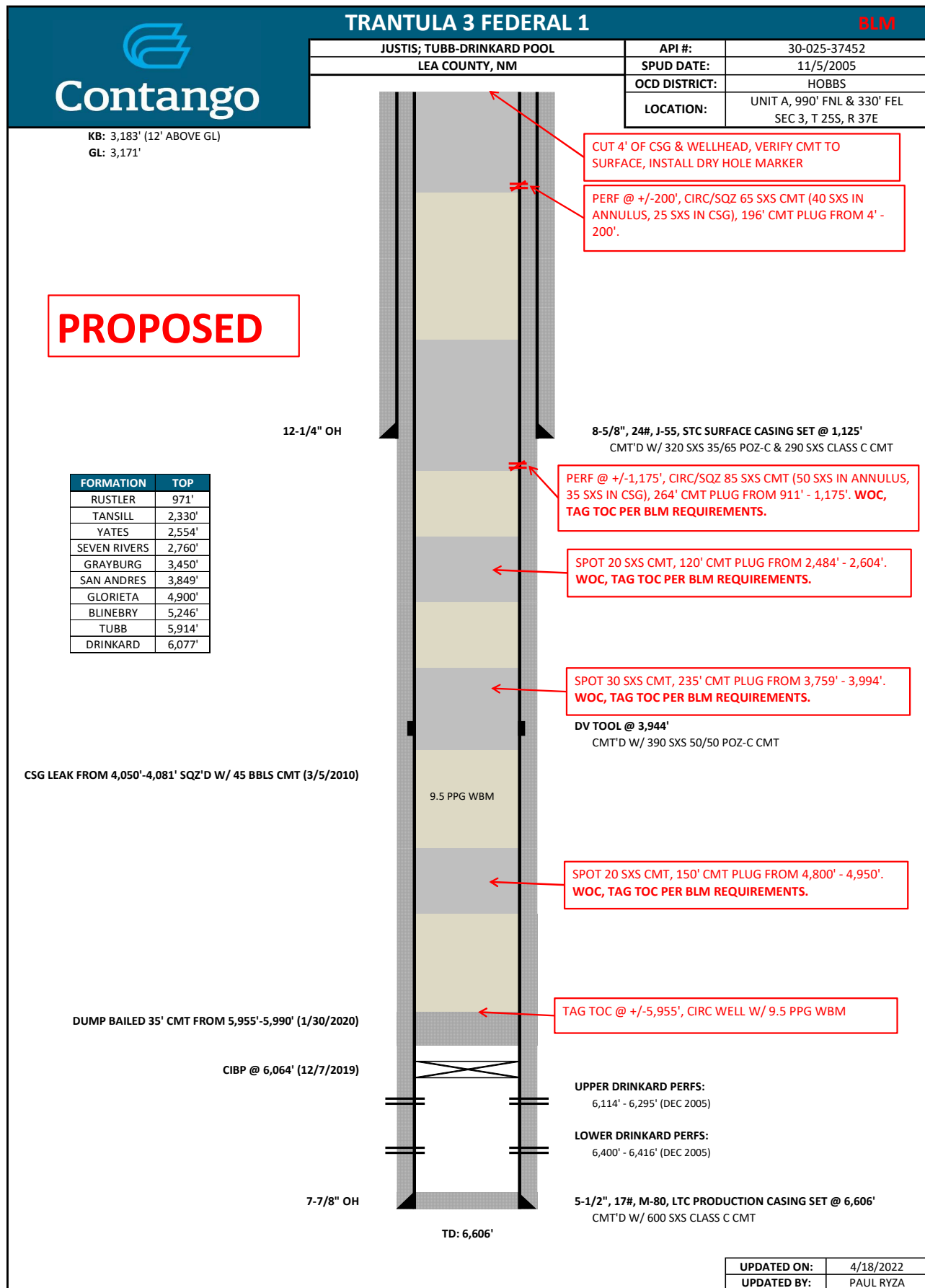
