Procedure Description: DJR Operating has an approved APD for the subject well. US Well Number: 30-043-21407. DJR respectfully requests to change the Surface Casing & Cement Program. Original plans were to drill the 12.25" surface hole to 350'. Due to foreseen issues with formation stability, DJR requests approval to drill the 12.25" surface hole to 800'. Set 9.625" 36# J55 STC casing from surface to 800' & cement with Type I-II with 50% excess. New slurry volumes calculated: 70 bbls (245 sx) at 14.5 ppg, 1.61 yield, 7.41 gps. Attached please find revised wellbore diagram with 9.625" surface casing and cement assumptions.

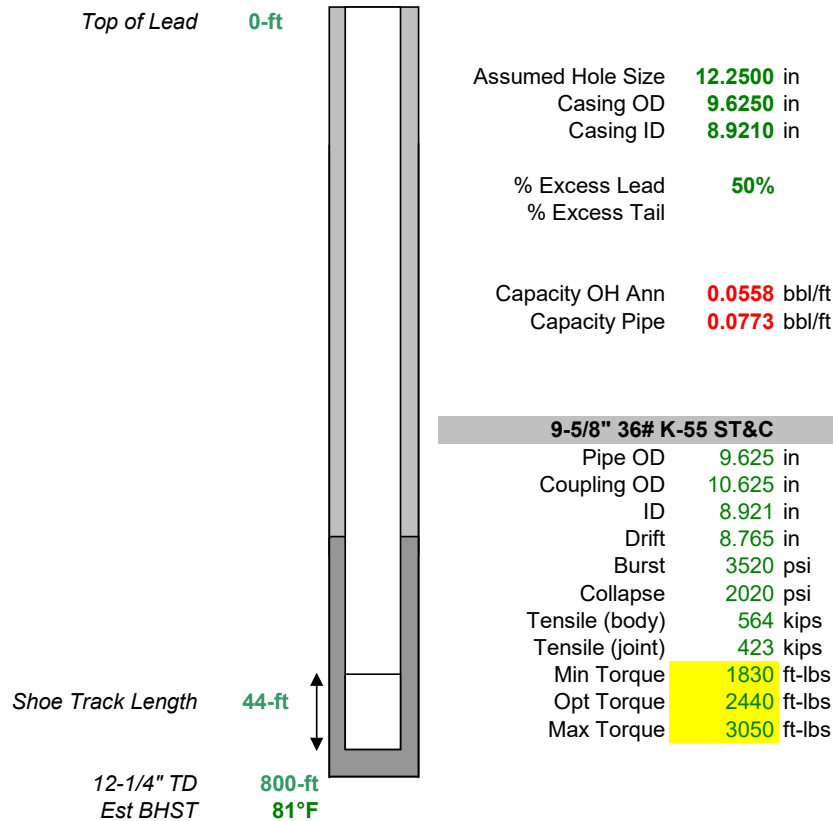
