

PROJECT OBJECTIVE:

Top off the casing with packer fluid. Rig up chart recorder and conduct mechanical integrity test.

WORKOVER PROCEDURE:

1. Contact regulatory to ensure test has been scheduled with NMOCD.
2. Hold safety meeting. Comply with all LOGOS, BLM and NMOCD rules and regulations.
3. Top off the 5-1/2" casing with packer fluid at least 24 hours before the pressure test.
4. RU chart recorder to chart pressure test as follows:
 - **Top off with packer fluid, if needed.**
 - **Record pressure on 1 hour chart with 560 psig for 30 minutes with a 1000-pound spring.**
 - **Contact engineer with results of pressure test.**
5. Bleed off pressure.
6. RD chart recorder.

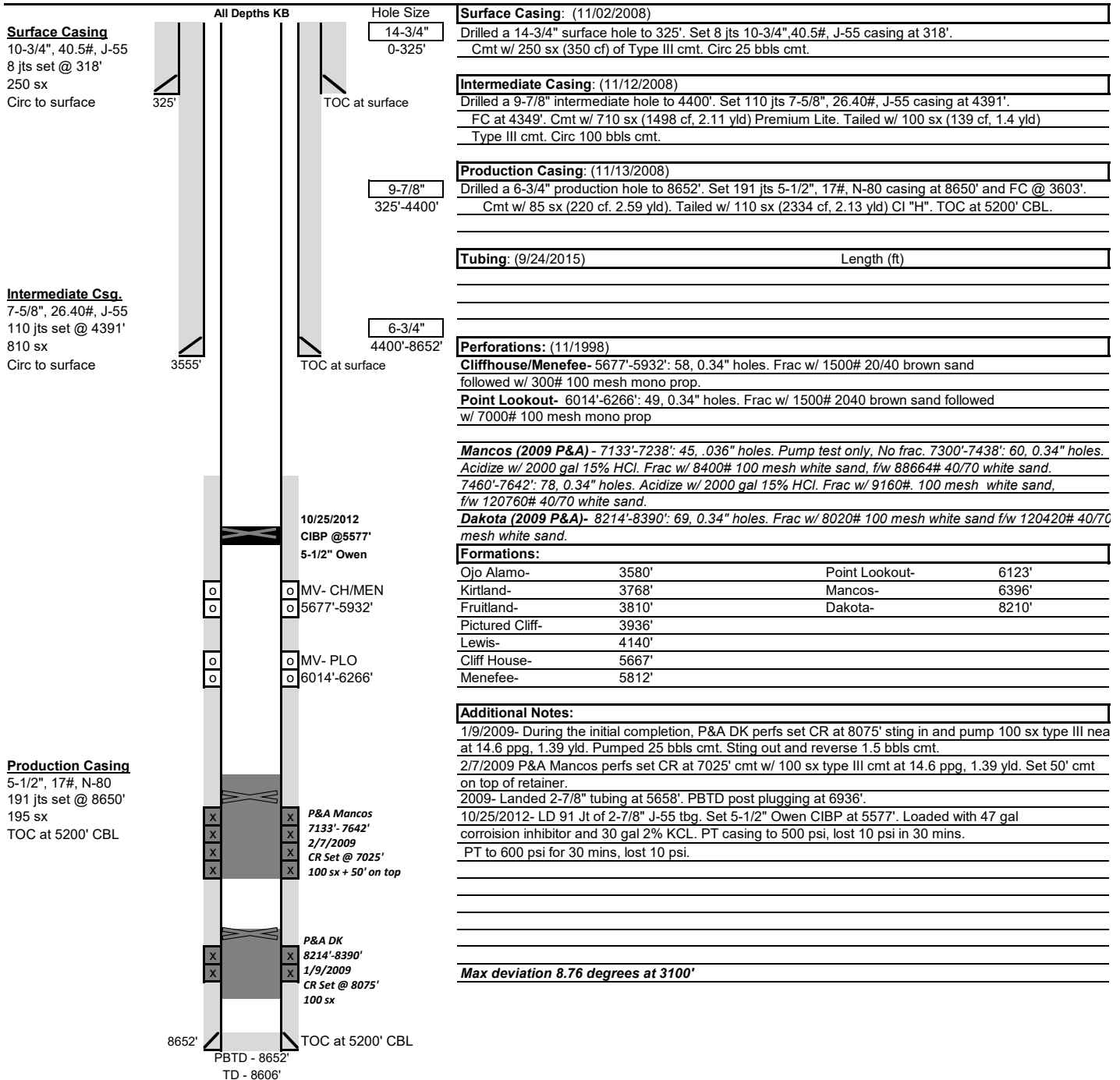
