**Actual Procedure:** Well spud on 3/20/2022 at 07:45 3/20/2022: Drill 17.5 inch surface hole to 1150 ft. Run 13.37 inch 54.5 lb J-55 surface casing to 1135 ft. Pump 20 bbls fresh water, 40 bbls gel spacer, followed by 695 sks of 13.5 ppg lead and 280 sks of 14.8 ppg tail. Drop plug and displace with 169 bbls brine. 149 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
