Marker jts at 5864' – 6636' – 9759' – 12767'. RU to cement. 5000 psi test on lines. Test good. Class G cement with 82% excess: 232 bbls (859 sx) 13.3 ppg, 1.52 yield, 7.53 gps. Bump plug 972 FCP, pressure up to 1450 psi & hold for 5 min. Full spacer with trace of cement back to surface. TOC: 5294' BOC: 12986'. No regulatory agencies onsite to witness. Install pack off.
