



Wellbore is temporarily abandoned, following passing MIT, with no tubing in the hole. Multiple CBL's have been run showing TOC at 900'.

Procedure:

- 1. RU crane and equipment
- 2. ND flange head, NU frac stack
- 3. Set composite bridge plug at 5450'
- 4. RU wellcheck and MIT wellbore to 500 PSI
- 5. Relieve pressure and pressure back up to max frac pressure
- 6. RD wellcheck and await frac arrival.
- 7. MIRU frac spread.
- 8. Perforate and frac the Mesa Verde from 4,500' to 5,440'.
- 9. Perforate and frac the Chacra from 3980' to 4350'.RDMO frac spread.
- 10. MIRU service rig.
- 11. Test BOP's.
- 12. PU mill and RIH to clean out to Dakota isolation plug.
- 13. When water and sand rates are acceptable, flow test the intervals.
- 14. Will not drill out Dakota Isolation plug.
- 15. TIH and land production tubing.
- 16. ND BOP's, NU production tree.
- 17. RDMO service rig & turn well over to production.

1. PRE- RECLAMATION SITE INSPECTION

A pre-reclamation site inspection was completed with Roger Herrera from the BLM and Eufracio Trujillo, Hilcorp Energy SJ South Construction Foreman, on August 3, 2022.

2. LOCATION RECLAMATION PROCEDURE

- 1. Reclamation work will begin in the fall.
- 2. All trash and debris will be removed within a 25' buffer outside of the location disturbance during reclamation.
- 3. Brush hog location and fence off area for disturbance.
- 4. Level off pad to accommodate for equipment.
- 5. Blade roads into location.
- 6. Fix damage to roads, TUA surfaces that are disturbed, fix drainage, and clean out culverts.
- 7. Put in water diversion bars where they are now.
- 8. Reclaim all disturbed area being used for recompletion activities.
- 9. Reestablish teardrop on location.
- 10. Reclaim areas damaged by moving crews in.

3. **SEEDING PROCEDURE**

- 1. A Pinion/Juniper seed mix will be used for all reclaimed and disturbed areas of the well pad(s) and lease road.
- 2. Drill seed will be done where applicable and all other disturbed areas will be broadcast seeded and harrowed. Broadcast seeding will be applied at a double the rate of seed.
- 3. Timing of the seeding will be when the ground is not frozen or saturated.

4. WEED MANAGEMENT

1. No action is required at this time for weed management, no noxious weeds were identified during this onsite.

VI. Separation Equipment:

Hilcorp Energy Company (HEC or Operator) production facilities include separation equipment designed to efficiently separate gas from liquid phases to optimize gas capture based on projected and estimated volumes from the targeted pool of our recomplete project. HEC will utilize flowback separation equipment and production separation equipment designed and built to industry specifications after the recomplete to optimize gas capture and send gas to sales or flare based on analytical composition. HEC operates facilities that are typically one-well facilities. Production separation equipment is upgraded prior to well being completed, if determined to be undersized or inadequate. This equipment is already on-site and tied into our sales gas lines prior to the recomplete operations.

VII. Operational Practices:

- 1. Subsection (A) Venting and Flaring of Natural Gas
 - HEC understands the requirements of NMAC 19.15.27.8 which outlines that the venting and flaring of natural gas during drilling, completion or production operations that constitutes waste as defined in 19.15.2 are prohibited.
- 2. Subsection (B) Venting and Flaring during drilling operations
 - This gas capture plan isn't for a well being drilled.
- 3. Subsection (C) Venting and flaring during completion or recompletion
 - Flowlines will be routed for flowback fluids into a completion or storage tank and if feasible under well
 conditions, flare rather than vent and commence operation of a separator as soon as it is technically feasible for
 a separator to function.
 - At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.
- 4. Subsection (D) Venting and flaring during production operations
 - At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.
 - Monitor manual liquid unloading for wells on-site or in close proximity (<30 minutes' drive time), take
 reasonable actions to achieve a stabilized rate and pressure at the earliest practical time, and take reasonable
 actions to minimize venting to the maximum extent practicable.
 - o HEC will not vent or flare except during the approved activities listed in NMAC 19.15.27.8 (D) 1-4.
- 5. Subsection (E) Performance standards
 - All tanks and separation equipment are designed for maximum throughput and pressure to minimize waste.
 - If a flare is utilized during production operations it will have a continuous pilot and is located more than 100 feet from any known well or storage tanks.
 - At any point in the well life (completion, production, inactive) an audio, visual and olfactory inspection be performed at prescribed intervals (weekly or monthly) pursuant to Subsection D of 19.15.27.8 NMAC, to confirm that all production equipment is operating properly and there are no leaks or releases.
- 6. Subsection (F) Measurement or estimation of vented and flared natural gas
 - o Measurement equipment is installed to measure the volume of natural gas flared from process piping.
 - When measurement isn't practicable, estimation of vented and flared natural gas will be completed as noted in 19.15.27.8 (F) 5-6.

VIII. Best Management Practices:

- 1. Operator has adequate storage and takeaway capacity for wells it chooses to recomplete as the flowlines at the sites are already in place and tied into a gathering system.
- 2. Operator will flare rather than vent vessel blowdown gas when technically feasible during active and/or planned maintenance to equipment on-site.
- 3. Operator combusts natural gas that would otherwise be vented or flared, when technically feasible.
- 4. Operator will shut in wells in the event of a takeaway disruption, emergency situation, or other operations where venting or flaring may occur due to equipment failures.




