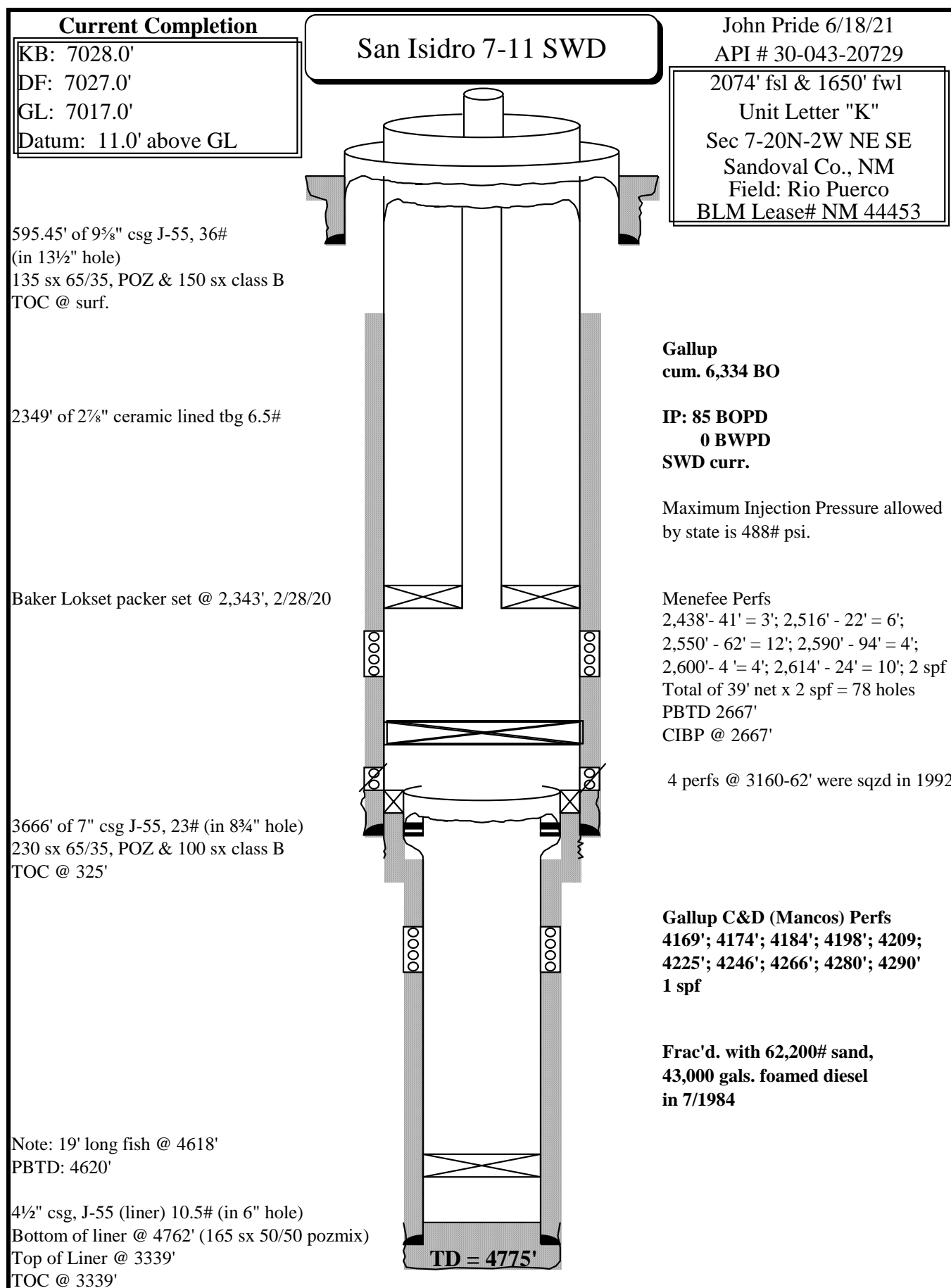

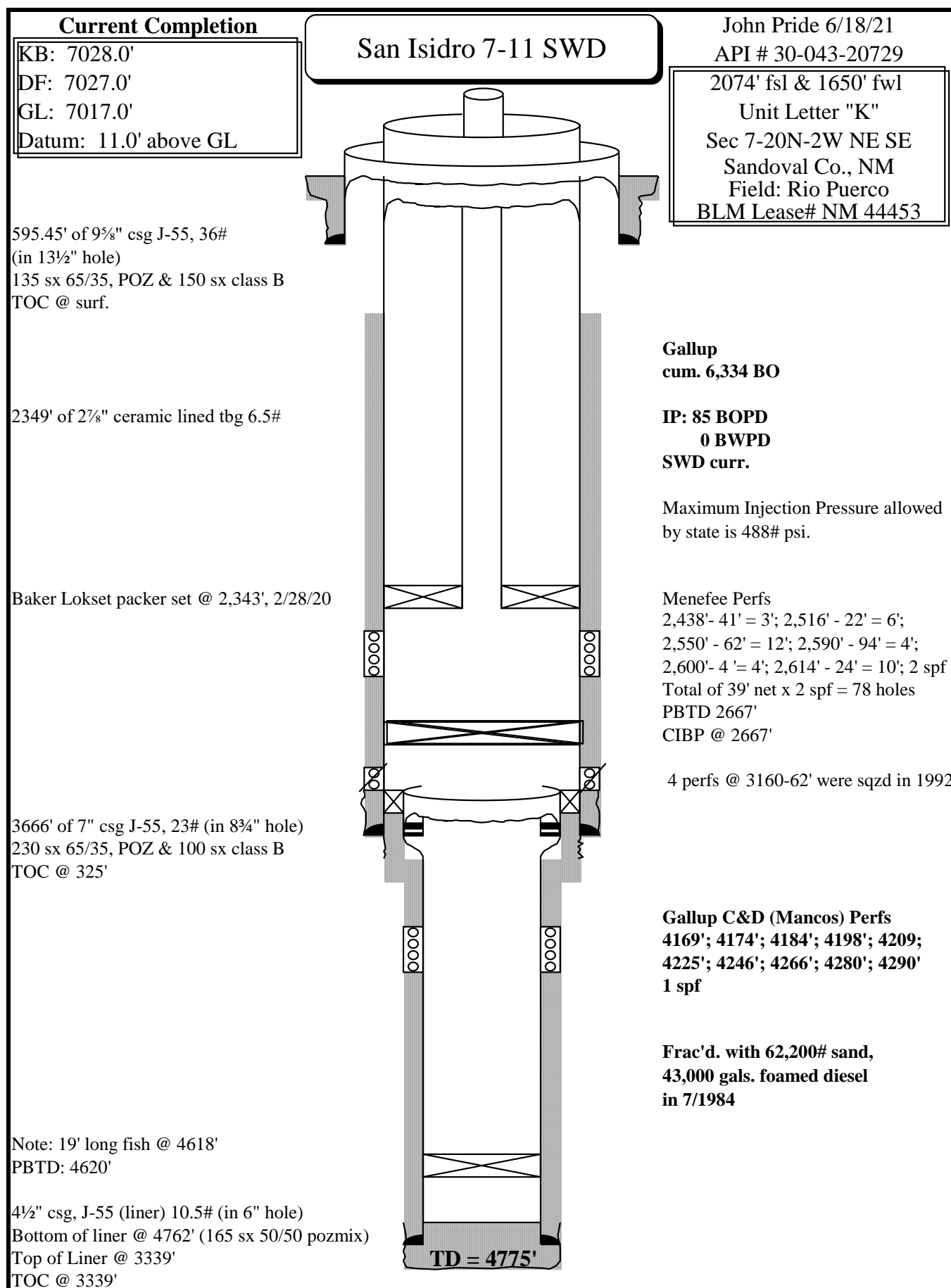

mkuehling	From UIC Engineering: If operator is not able to set packer at 2,350 feet or deeper, then the operator shall have the option to set the packer no shallower than 2,312 feet to obtain a proper seal and successful MIT. If the packer setting depth is below or at 2,312 feet, then the operator shall submit a request with the required information for a Packer Setting Depth Exception to the OCD Engineering, UIC Group. If the packer setting depth is above 2,312 feet, then the operator shall have to reapply for a new UIC permit and new evaluation of the Exempt Aquifer determination. Well files are incomplete - Operator shall provide all forms and documents associated with this well as required under 19.15.7.9 NMAC.	8/25/2022
