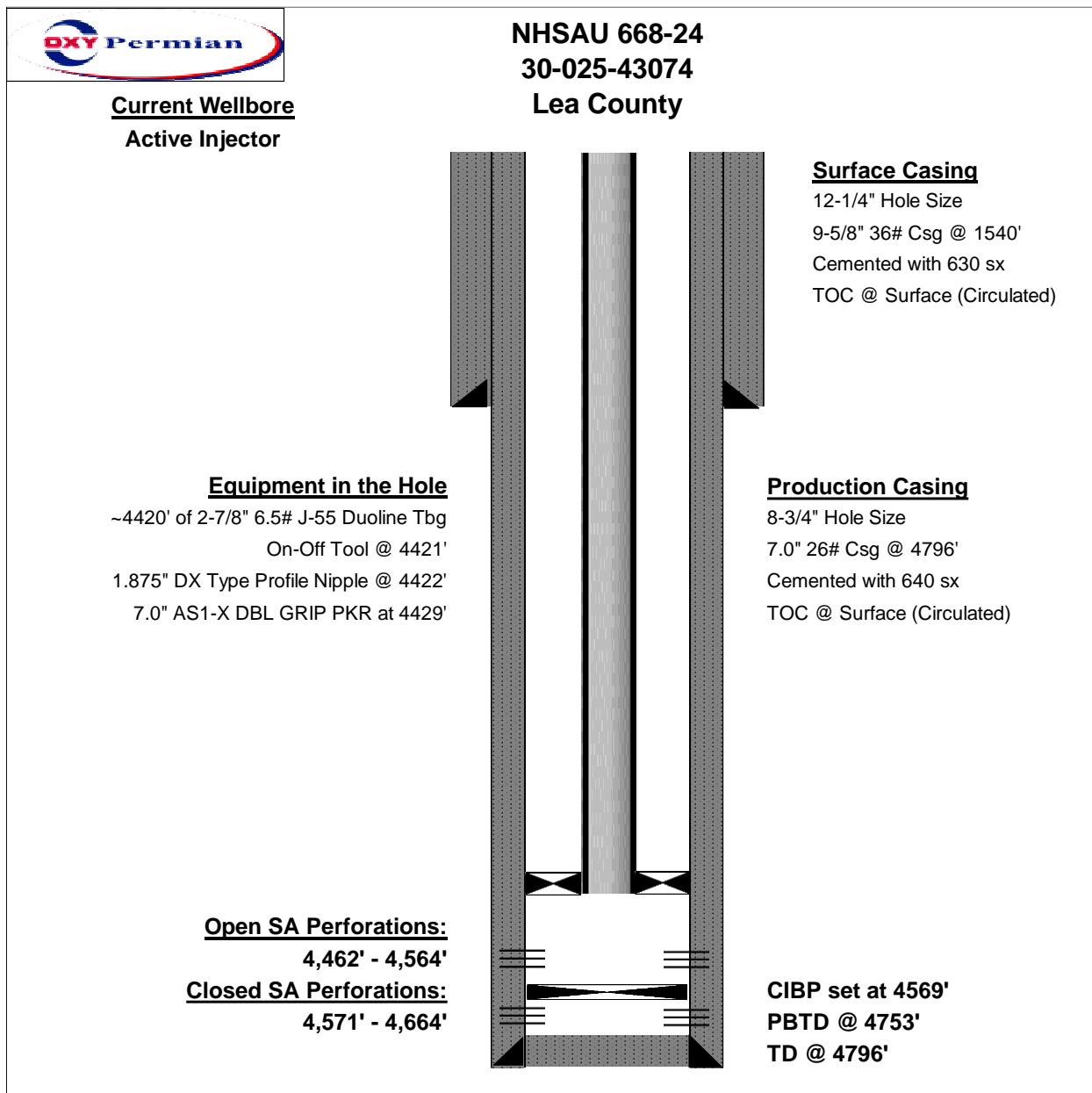
Planned Procedure - OAP

Objective: Open additional pay within the same unitized San Andres interval (Z2L, 3E, & 3F).

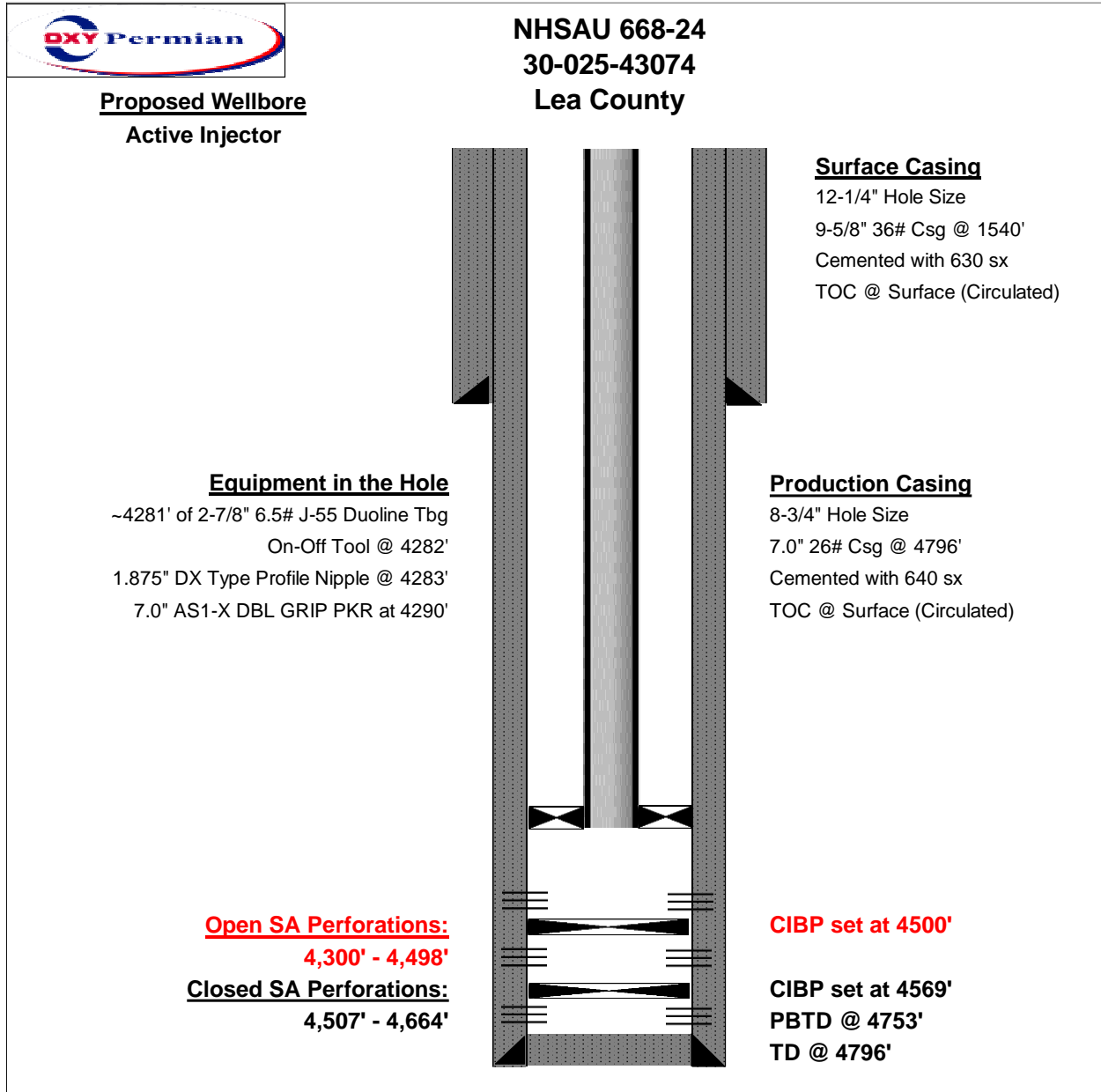
Procedure:

1. MIRU PU
2. Kill well x ND WH x NU BOP
3. POOH with Inj Eqpt
4. RU WL
5. Set CIBP @ ~4500'
6. Perforate well from 4300'-4450' @ 3 spf
7. Acidize new perfs in 6 stages with ~3500 gal 15% HCL using PPI tool
8. RIH with injection equipment
9. RD PU
10. Return well to injection.
