Pump 20 bbls fresh water, followed by 405 sks of 148 ppg tail cmt. Drop plug and displace with 20 bbls fresh water, 28 bbls brine. 40 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
