Pump 20 bbls fresh water, followed by 860 sks of 10.5 ppg lead cmt, 235 sks of 13.2 ppg tail cmt. Drop plug and displace with 464 bbls of fresh water. 200 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 2232 for 30 minutes, good test. 4/28/2022: Drill 6.75 inch production hole to 15726 ft. 5/15/2022: Run 5.5 inch 20 lb P-110 production casing to 15743 ft MD. Pump 40 bbls spacer, then 350 sks of 13.5 lead cmt, 420 sks of 14.5 ppg tail cmt. Drop plug and displace with 20 bbls sugar water, 308 bbls brine and 20 bbls fresh water. 10 bbls spacer returned to surface. Est TOC at 650 ft.
