ADJUSTED COA FROM OCD AS FOLLOWS: There is a gap in perforations on the fruitland giving room to do a plug at the pc. Please run plug on PC 50 feet below top and 100 feet (that is 50 feet above top of pc with 100% excess making 100 feet) above top of pc. Running a plug of 150 feet. Open ended is fine just make sure tubing is 50 feet below top of pc. You may lose the cement in the perforations. Tagging is required – please let me know what the tag is. As long as there is a good pressure test you are approved to combine Ojo Kirtland Surface shoe to surface – 636 to surface. (also as long as bradenhead 1 to 0.)


