Hamms State 223H – Intermediate and Production

3/3/2022: Test BOPS. Drill 9.875 intermediate hole to 9259 ft.

3/7/2022: Run 7.625 inch 29.7 lb P-110 intermediate casing to 9150 ft. Pump 20 bbls chem wash, 20 bbls vis water, followed by 878 sks of 10.5 ppg lead cmt, 294 sks of 13.2 ppg tail cmt. Drop plug and displace with 418 bbls of freshwater. 258 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

3/19/2022: Drill 6.75 inch production hole to 14505 ft

3/23/2022: Run 5.5 inch 20 lb P-110 production casing to 14489 ft MD. Pump 40 bbls MPE, 102 bbls MRF, then 476 sks of 14.5 ppg tail cmt. Drop plug and displace with 10 bbls sugar water, 211 bbls brine. 10 bbls MPE returned to surface. Est TOC at 8159 ft.
