Hyperion State 181H Intermediate and Production Casing

8/25/2022: Test BOPS. Drill 12.25 intermediate hole to 5303 ft.

8/26/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5288 ft. Pump 20 bbls vis water, followed by 780 sks of 11.0 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls fresh water and cut brine. 88 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

8/26/2022: Drill 8.75 inch production hole to 9396 ft then switch to 6.75 in hole to 14974 ft.

9/1/2022: Run 5.5 inch 20 lb P-110 production casing to 14959 ft MD. Pump 40 bbls fresh water, then 405 sks of 10.5 lead cmt, 790 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 311 bbls fresh water. 0 bbls returned to surface. Est TOC at 2875 ft.
