8/14/2022: Test BOPS. Drill 12.25 intermediate hole to 5354 ft.

8/15/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5339 ft. Pump 20 bbls fresh water, followed by 840 sks of 11.0 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 401 bbls fresh water. 32 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

8/16/2022: Drill 8.75 inch production hole to 9525 ft then switch to 6.75 in hole to 20355 ft.

8/30/2022: Run 5.5 inch 20 lb P-110 production casing to 20335 ft MD. Pump 40 bbls gel spacer, then 360 sks of 10.5 lead cmt, 1130 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 420 bbls brine. 0 bbls returned to surface. Est TOC at 2042 ft.
