Actual Procedure: Intermediate Casing & Cement. Depths have been adjusted for 26' KB of production rig. 5/20/22: H&P Rig 443 accepted on daywork. NU 11" 3M BOP with installed 11" 5M Cameron wellhead. PT annular, TIW, blind rams, HCR, pipe rams, kill valves, check valve, lower kelly, choke manifold, full opening safety valve and inside BOP valve at L250 (5 min) H3000 (10 min). PT pre-set 9.625 inch 36# J55 STC surface casing 1500 (30 min). All tests good and recorded on chart (3rd party Wilson Services). No regulatory agencies on site to witness. Drill 8.75" hole to 5762' MD (KOP 4807'MD / 4760 TVD). 5/24/22: RU casing crew. Run 139 jts of 7" 26# LTC casing set from surface to 5755'. RU to cement. 5K test on lines. Test good. Cement with 78% excess on lead 0% excess on tail. LEAD: 199 bbls (449 sx) 12.3 ppg, 2.50 yield, 13.9 gps, (Surface to 4328'). TAIL: 38 bbls (138 sx) 13.5 ppg, 1.57 yield, 7.4 gps, (4328' to 5755'). Total sx: 587. Bump plug 1333 FCP, pressure up to 2500 & hold for 5 min. Circulate. 38 bbls good cement to surface. No regulatory agencies on site to witness. RD CRT. Install pack off & test to 5K. Test good. ND BOP. Skid to next well.
