**Actual Procedure:** Well spud on 4/1/2022 at 00:00 4/1/2022: Drill 17.5 inch surface hole to 360 ft. Run 13.375 inch 54.5 lb J55 surface casing to 344 ft. Pump 20 bbls fresh water and 20 bbls brine, followed by 405 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls fresh water, 20 bbls brine, 4 bbls fresh water. 47 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 4/1/2022, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 344 ft, Cement 405 sacks, Yield 1.34 tail, Class C.
