BLM (Dillion Haliburton) gave permission to proceed with test without witness. 9/28/22- Pressure tested surface casing. Initial test failed. OCD (Monica Kuehling) was on location and witnessed failed test. Surged the well a couple of times, then tested to 1200 psi for 30 minutes (good). Pressure dropped to 1190 psi. Test chart sent to OCD (Monica Kuehling), gave approval. Landed @ 3310', FC @ 3267'. TEST 9 5/8" CSG TO 1500PSI F/ 30 MIN Good test.
