NDWH, NU BOP. Pull 1 1/4" tubing. RIH with gauge ring to 2240'. POOH. TIH with 2 3/8" workstring and cement retainer, set CR at 2230'. Load and roll the hole. PT casing, did not test.

P&A Plug 1: Pictured Cliffs perforations: Mix and pump 10 sx through CR and into Pictured Cliffs perforations. TOOH.

Run CBL from 2230' to surface. TOC 800'.

8-23-2022:

P&A Plug 2: TIH to 2230'. Pictured Cliffs, Fruitland, Kirtland and Ojo Alamo formation tops: Mix and spot plug of 42 sx above CR from 2230'. WOC.

TIH, tag Plug 2 at 1651'. Pull up to 1194'.

P&A Plug 3: Nacimiento formation top: Mix and pump balanced plug of 12 sx from 1194'. WOC.

8-24-2022:

TIH, tagged Plug 3 at 1004'. PT casing, did not test. TOOH.

RIH, perforate holes at 211'. Establish circulation out BH.

P&A Plug 4: Surface casing shoe to surface. Mix and pump 65 sx down casing and out BH, good cement returns out BH.

Cut off WH. TOC at surface. Install P&A marker. Top off casing and cellar with 20 sx.

Release rig.

All cement used: Class G cement mixed at 15.8 ppg, yield 1.15

We will eliminate the 6 ft. dry hole marker and use a permanent metal plate that will be installed at ground level, effective September 2019. The marker will contain the following information:

- Well Pad Lease Number
- Well Pad Location Name and Number
- Well Pad Legal Description, specifically Section, Township and Range
- Well Pad API Number
- Well Pad Plug Date
- Well Pad Operator Name



8-24-2022: PT casing, did not test.

8-23-2022: Plug 3: Nacimiento top: Mix and pump a balanced plug of 12 sx from 1194'. 8-24-2022: Tagged Plug 3 at 1004'.

8-23-2022: Plug 2: Pictured Cliffs, Fruitland, Kirtland, and Ojo Alamo: Mix and spot a balanced plug of 42 sx from 2230'. WOC, Tagged Plug 2 at 1651'.

8-22-2022: Run CBL from 2230' to surface. TOC at 800'.

8-22-2022: Plug 1: Pictured Cliffs perms: Set CR at 2230'. PT casing, did not test. Mix and pump 10 sx cement through CR from 2230' to 2314'.
