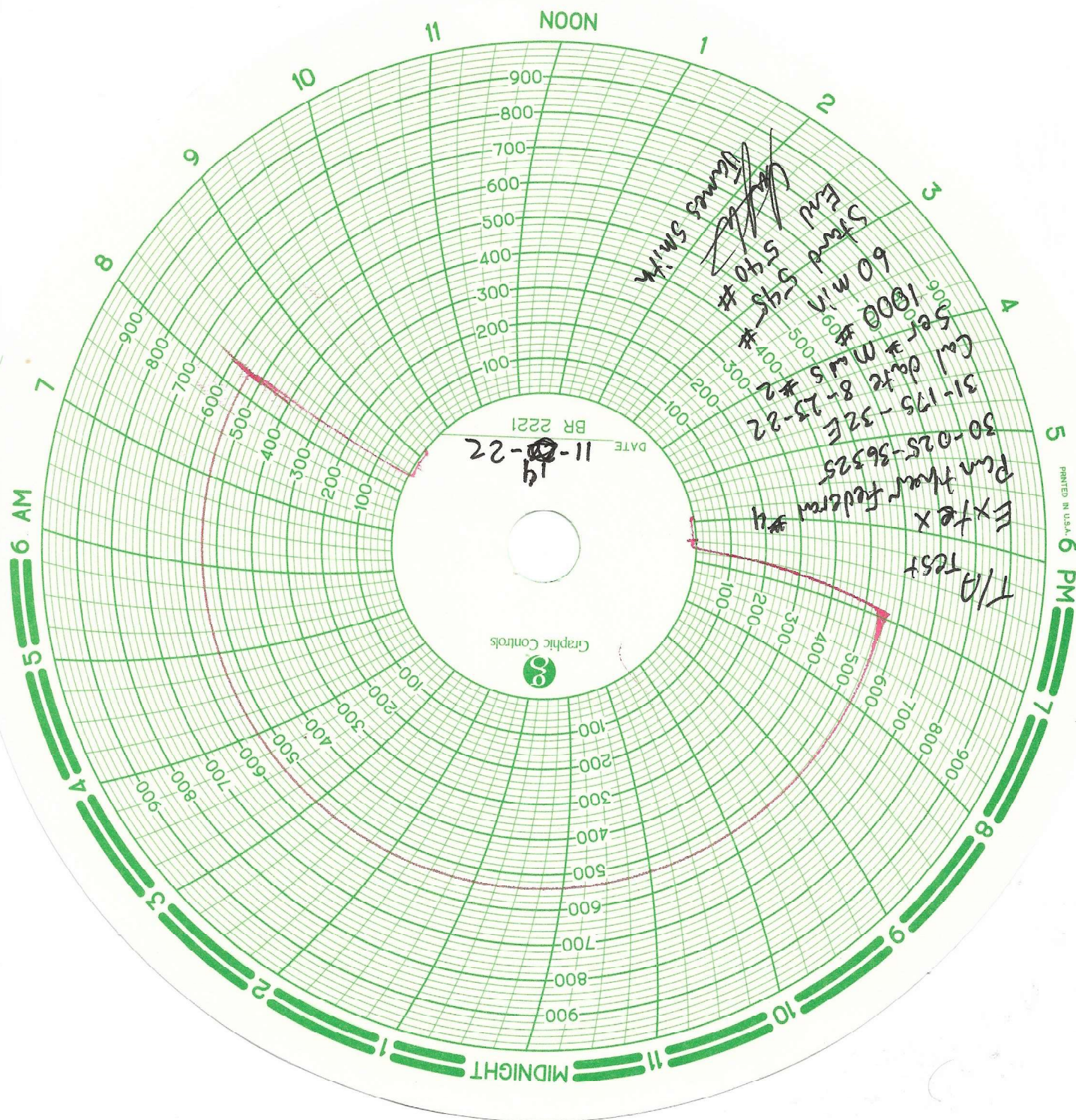

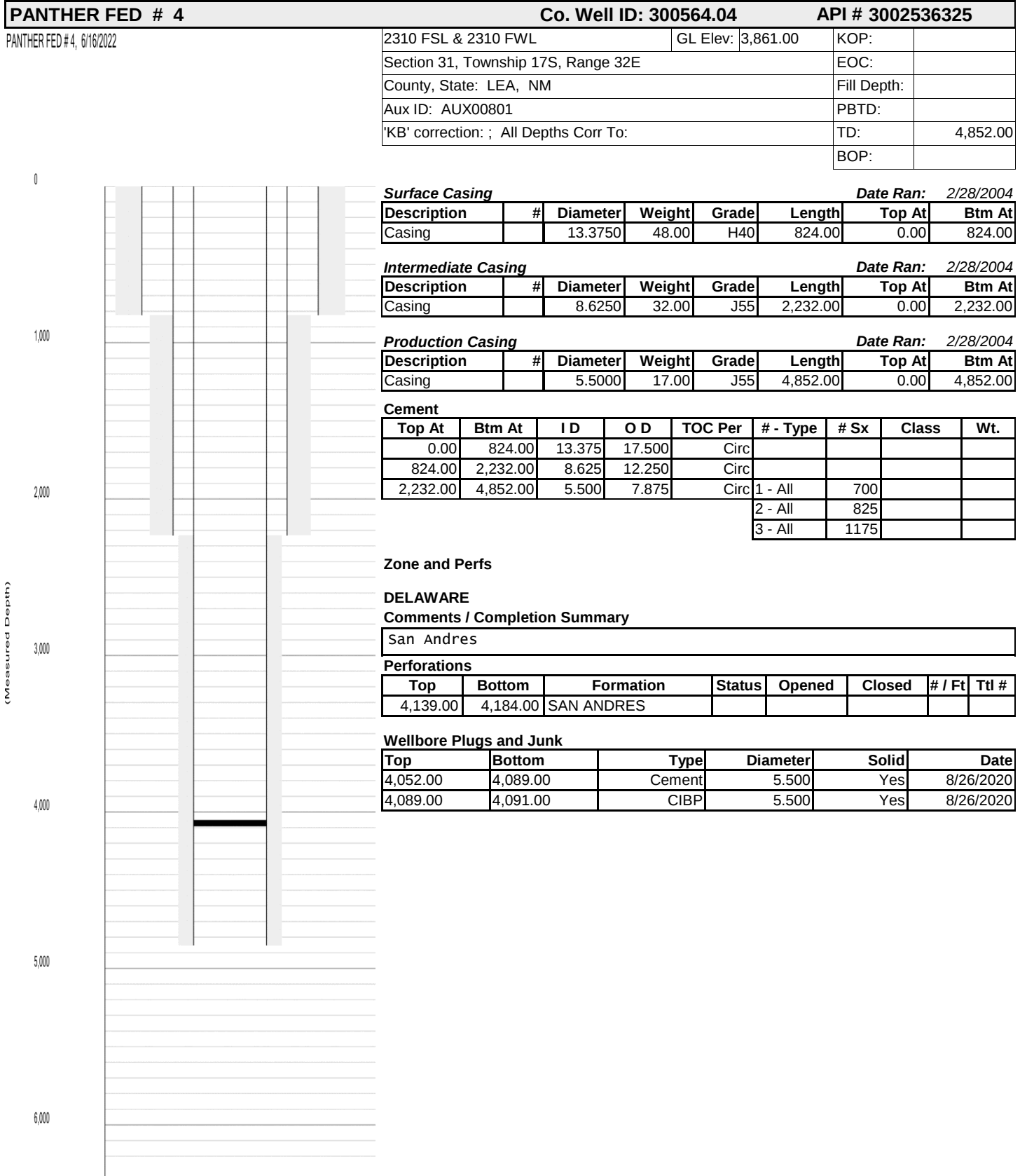
MIT Work Plan

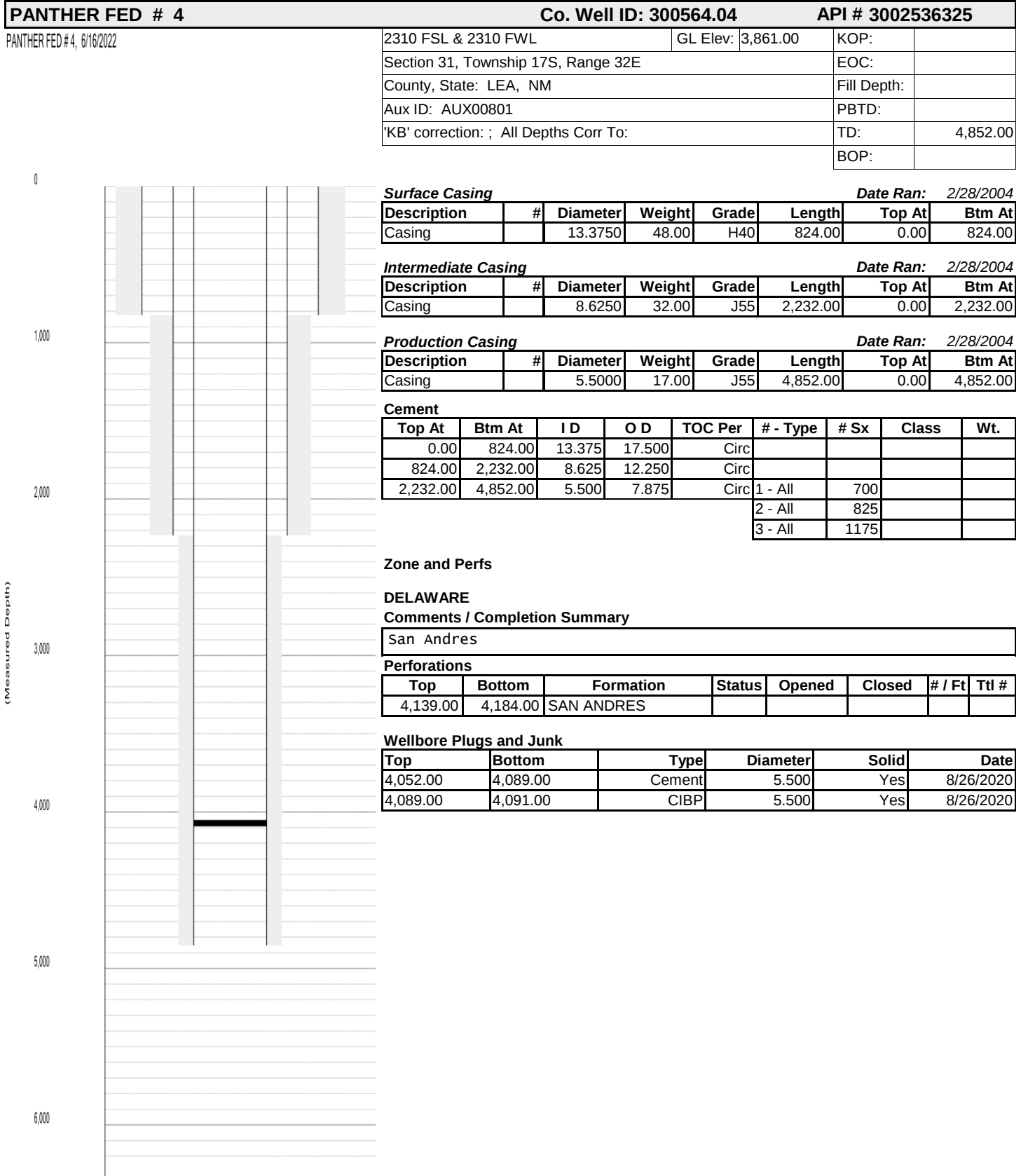
