Procedure:

1. TOOH with Production Equipment. Rods/Tubing/Pump from ~ 3650'
2. PUMU 5.5" Scraper. RIH to 3250'
3. Set 5.5" CIBP @ 3225'
4. Spot 35' cement with bailer or 25sx if pumping.
5. Tag cement top. Record depth.
6. Circulate well and load casing with inert fluid
7. Notify NMOCD for MIT.
