MIRU rig and equipment. SITP = 0, SICP = 740, BH = 10. Unseat pump, LD 2 rods. Hot oil with 50 bbl water. Pull 50 7/8" rods. SDFN.

11-29-2022:

SITP = 0, SICP = 25, BH = 0. Finish pulling rods and pump. NDWH, NU BOP.

Start pulling 2 3/8" production tubing. Pulled 65 joints, started getting heavy paraffin. SD.

P&A Plug 6: Ojo Alamo formation top, surface casing shoe to surface: Mix and spot balanced plug of 70 sx from 505' to surface. TOOH.

Cut off WH. Had to dig deep due to large WH. TOC, 80' in annulus and at surface in casing. Install P&A marker. Top off casings and cellar with 70 sx. Release Rig.


