Good Morning,

I was looking over the approved APD's for the Jeff Smith MDP1 7-18 Fed Com 171H/172H/173H/174H that we are planning on moving a rig to in the near future to drill surface hole, and I noticed that the surface casing weight is incorrect. In the APD's (and subsequent drill plan that Oxy submitted), the surface casing is listed as 10-3/4" 40.5# J-55 BTC, but we should actually be running 10-3/4" 45.5# J-55 BTC. Do we need to submit a sundry due to this change? The rest of the casing and well design is correct.
