Displaced csg w/78 bbls of BW. Plug Down @ 3:00 P.M. 07/27/22. Circ 243 sks cmt to pit. Tested BOPE to 5000# & Annular to 3500#. At 11:30 AM. 07/07/22, tested csg to 1500# for 30 mins, held OK. Drilled out with 12 1/4" bit. 07/30/22 TD'ed 12 1/4" hole @ 1905'. Ran 1890' 9 5/8" 40# HCL80 LT&C Csg. Cmt w/600 sks Class C w/2% CaCl2 (1.34 ft<sup>3</sup>/sk @ 14.8 PPG).
