Proposed TA Procedure

Notify OCD and BLM 24hrs prior to rigging up

Notify OCD and BLM 48hrs prior to MIT test

- 1. Move in, rig up well service unit.
- 2. Nipple down wellhead, nipple up BOP.
- 3. Unset packer, kill well if needed.
- 4. POOH with tubing while inspecting. If condition is good, rack back. If condition is bad, LD and order 8rd L80 work string.
- 5. Pick up & run in hole w/ bit & casing scraper. Pull out of hole.
- 6. Run in hole w/ 5.5" CIBP & set at 10,113'.
- 7. Pressure test CIBP to 500 psi for 15 minutes.
- 8. Circulate packer fluid.
- 9. Pull out of hole laying down workstring.
- 10. RU WL unit, Dump bail 35' of Class H cmt on top of CIBP.
- 11. Nipple down BOP, nipple up wellhead.
- 12. Rig down, move out well service unit.
- 13. Perform MIT test Notify OCD and BLM 48hrs prior to test pressure test casing to 500 psi for 30 minutes and record chart and fill out all pertinent information.
