This extension is necessary as a result of prioritized development in the upper Wolfcamp formation to best service depletion which thus delayed the development of the other targets. Otherwise, the simultaneous development and initial production of all prospective targets would have exceeded infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water.

EOG's goal is to spud these wells by January 8, 2023.
