RIH w/ WL to set 5-1/2" cement retainer @ 10,000'. 3/10/2023 PU stinger and RIH w/ tbg to tag and sting into cement retainer @ 10,004'. RU pump. Load tbg and pressured up to 500 psi. Bled off pressure. Stung out of retainer. Pumped down tbg and established circulation to surface. Stung back into cement retainer and pressured up to 500 psi. Sting out of retainer. 3/13/2023 M&P 25 sx Class H cmt to spot @ 10,002'. Displace w/ MLF. POOH w/ tbg and LD stinger. TIH w/ tbg to tag TOC @ 9791'. PU to set EOT @ 9761'. 3/14/2023 Circulate well w/ MLF. PU to set EOT @ 7035'. Spot 25 sx Class C cement @ 7035'. Calculated TOC @ 6778'. (No requirement to tag.) PU to set EOT @ 5020'. Spot 65 sx Class C cmt. Displace w/ MLF. POOH & LD 66 jts of tubing. Rig up WL to tag TOC @ 4658'. BLM requested additional 25 sx Class C cement. RIH to set EOT @ 4633'. Spot 25 sx Class C cement. 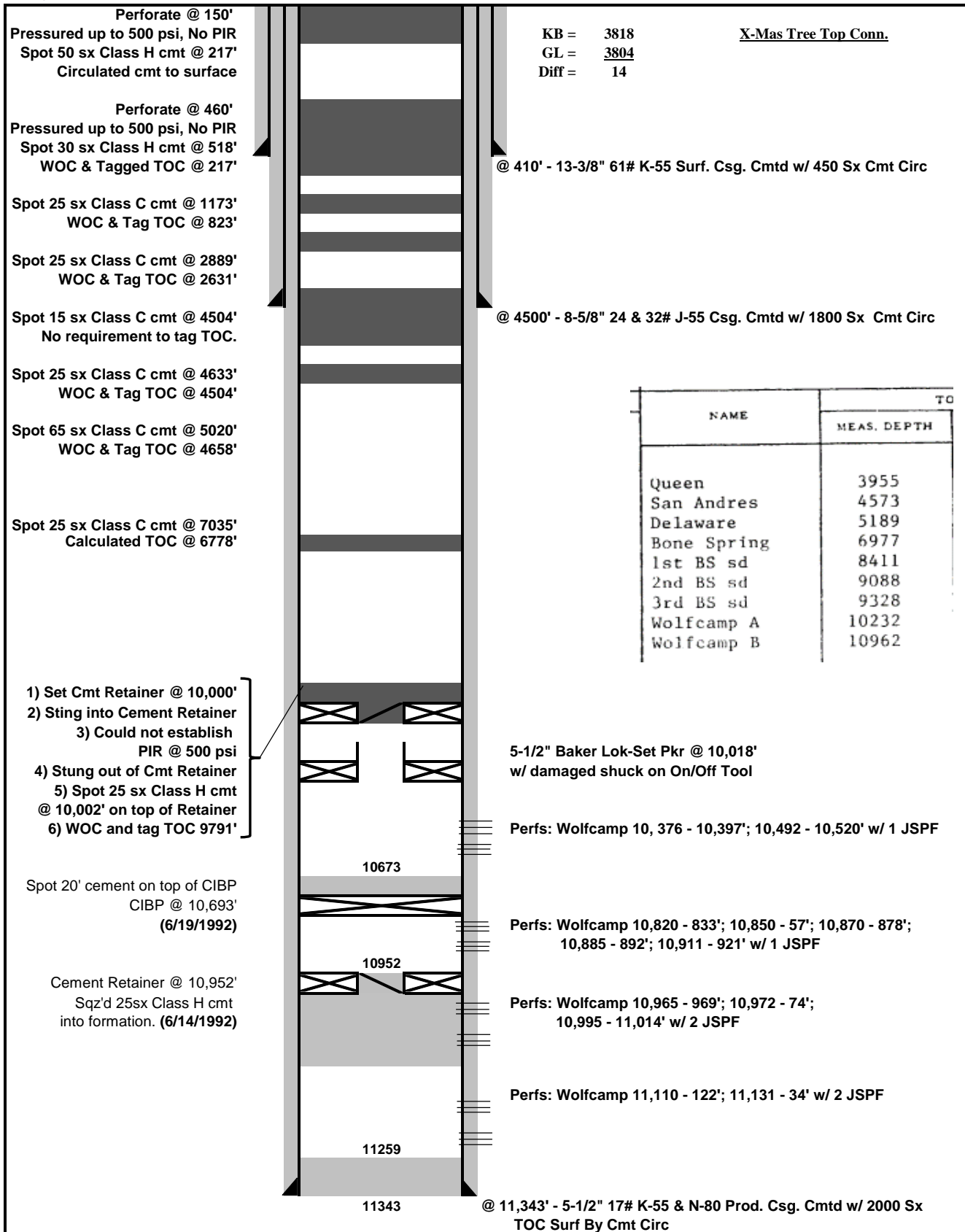
