4/24/2023 Moved in equipment, set matting board and rigged up. Installed BOP. Circulated MLF. POOH to 7312' and spot 25 sx cement. POOH to 6569' and spot 25 sx cement. POOH to 4517' and SION.

J&B Daily: 12431.62

4/25/2023 Spot 25 sx at 4517'. POOH and perforated at 2522'. Set packer and pressure up to 500# and held. Bled off at truck. Repeated to 750# with same result. POOH with packer and spot 25 sx cement with CaCl across perforations from 2572'. WOC and tagged at 2371'. Perforated at 1795'. Set packer at pressure up on perfs to 500#. Held. Bled off at the truck and repeated to 700# with same results. Pulled packer and spot 25 sx cement across perforations from 1852'. POOH and SION

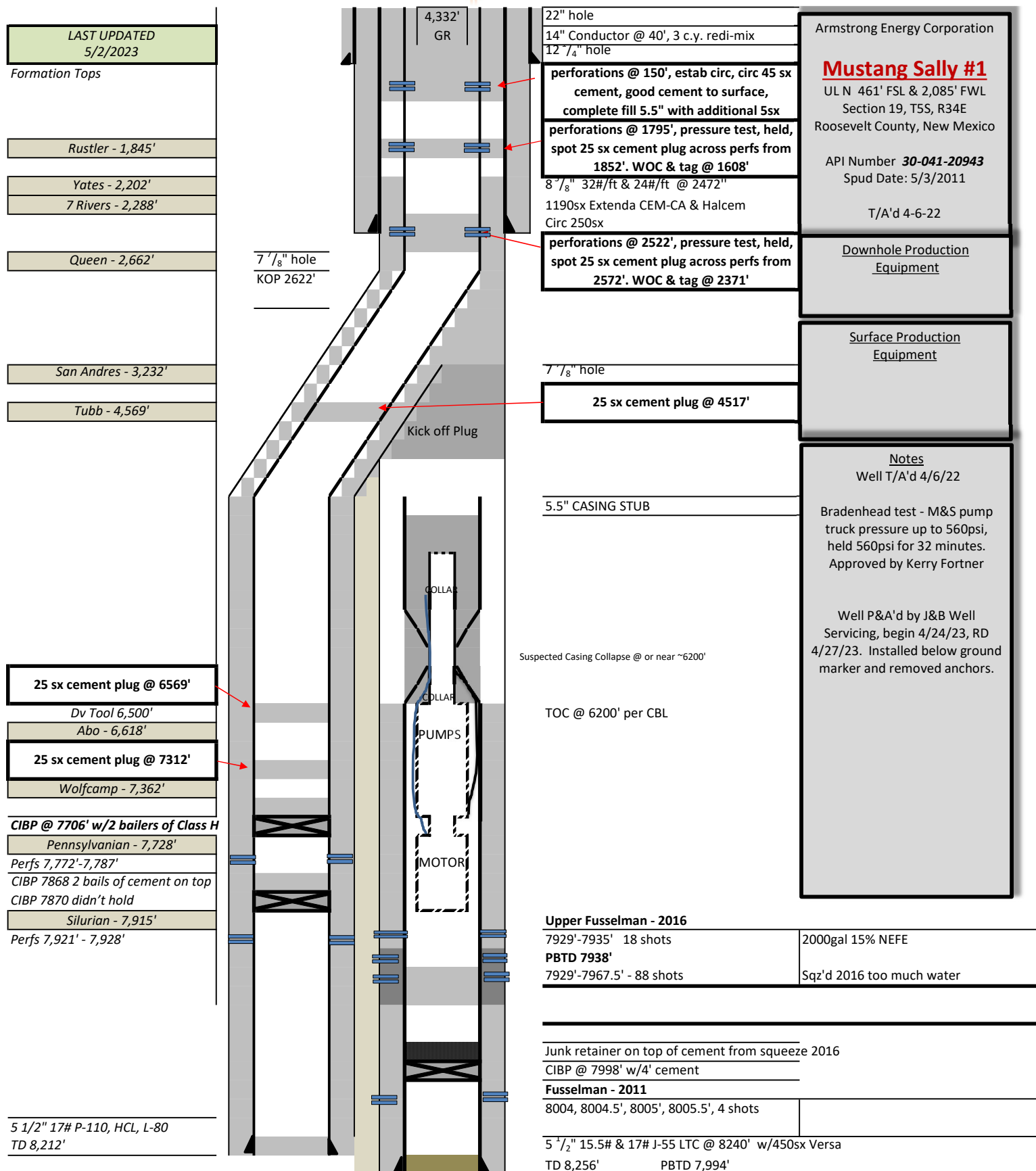
J&B Daily: 12463.23

4/26/2023 Tagged cement at 1608'. Perforated casing at 150'. Good communication. Pumped cement down the 5 ½" to perfs at 150' and up the surface annulus. Took 45 sx to get good cement to the pit. Prep to rig down and shut down for wind. M&S hauled 130 bbl to SWD.

J&B Daily: 6290.89

4/27/2023 Rigged down. Dug out and removed the wellhead. Filled up 5 ½" casing with 5 sx cement. Good cement to surface in the 8 5/8" casing. Installed BGM, removed the anchors, cleaned the pit and cleared location. M&S hauled fluid from pit to landfill.
