DVT set @ 3414 and ECP set @ 3416. Cement stage 1 with 280sx lead 11.5ppg 2.26yld 50/50 POZ C and tail 225sx 14.8ppg 1.33yld Class C. Stage 2 2600sx lead 11.5ppg 2.26yld 50/50 POZ C and tail 155sx 14.8ppg 1.33yld Class C. Cement did not circulate. Ran temp log. TOC at 1150' (1000' inside surface casing). Perf at 1120' and squeeze 446sx of 11.5ppg 2.26yld 50/50 POZ C. Circulate 186sx to surface.
