Pressure test casing to 650 psi for 30 minutes. Casing held good. Test passed. 3) Spot and circulate cement to surface from 1272' w/45 sks (51.75 cu ft) Class G cement (1.15 cu ft/sk. 15.8 #/gal). Circulate 1 bbl cement to surface. WOC 4 hrs. Cut wellhead off. Tag 13' inside 5½" annulus and @ surface inside 2-7/8". Plug I, inside 2-7/8", 45 sks, 51.75 cu ft, Pictured Cliffs-Fruitland-Kirtland-Ojo Alamo-Surface, 0-1272'. 4) Install below ground plate for dry hole marker as it is NAPI surface. 
