The request to extend the temporary abandonment (TA) is approved with the following conditions:

1. No well shall be TA without prior approval from the authorized officer or representative.
2. This approval is granted for a 6-month period until December 21, 2023. Before this approval expires one of the following shall be submitted:
  - a. A sundry notice (Notice of Intent – Temporary Abandonment) to keep the well in TA status with engineering and/or economic justification for up to another 12-month period.
  - b. A sundry notice (Notification – Resume Production) with resumption of production reported.
  - c. A sundry notice (Notice of Intent - Other) to convert the well from a producer to a water source well.
  - d. A sundry notice (Notice of Intent – Plug and Abandonment) to plug and abandon (P&A) the well. While not necessary to P&A before December 21, 2023, a sundry notice must be submitted prior to that date.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.

4. The lease is currently held by production from other wells. Should production from the lease cease, the BLM may require this well be returned to production or P&A, regardless of the amount of time the TA status is still approved for.

Well History

The Blanco Wash Unit 401H was drilled and completed as a horizontal Mancos producer in 2012. The well was shut-in in 2020. Temporary Abandonment approval and procedure was completed in 2021. Temporary Abandonment status expired on 12/22/2022.

Plans for Well

DJR is seeking approval through the State of New Mexico to convert the Blanco Wash Unit 401H to an Entrada Water Supply Well (WSW). Should the conversion application be approved, DJR will no longer require the use of the Blanco Wash WSW #001 well and pad which was previously approved by the BLM on January 12, 2022, by Sundry Notice. Using the Blanco Wash Unit 401H pad as a water supply well will save 3.7 acres of new surface disturbance on federal land.

Request for an additional 1-year extension is needed for:

- DJR to complete evaluation of the pad to ensure it will accommodate the water supply facility equipment and G-tank.
- Obtain a release from the NMOCD of the current wellbore including the filing of the "Affidavit of Responsibility", assigning jurisdiction of the wellbore to the Office of the State Engineer.
- Amend existing approval (SJ-4343) issued by the Office of the State Engineer to indicate the new location of the water supply well at the Blanco Wash Unit 401H pad.
- Prepare and submit all required documentation including well conversion procedure to the Office of the State Engineer.



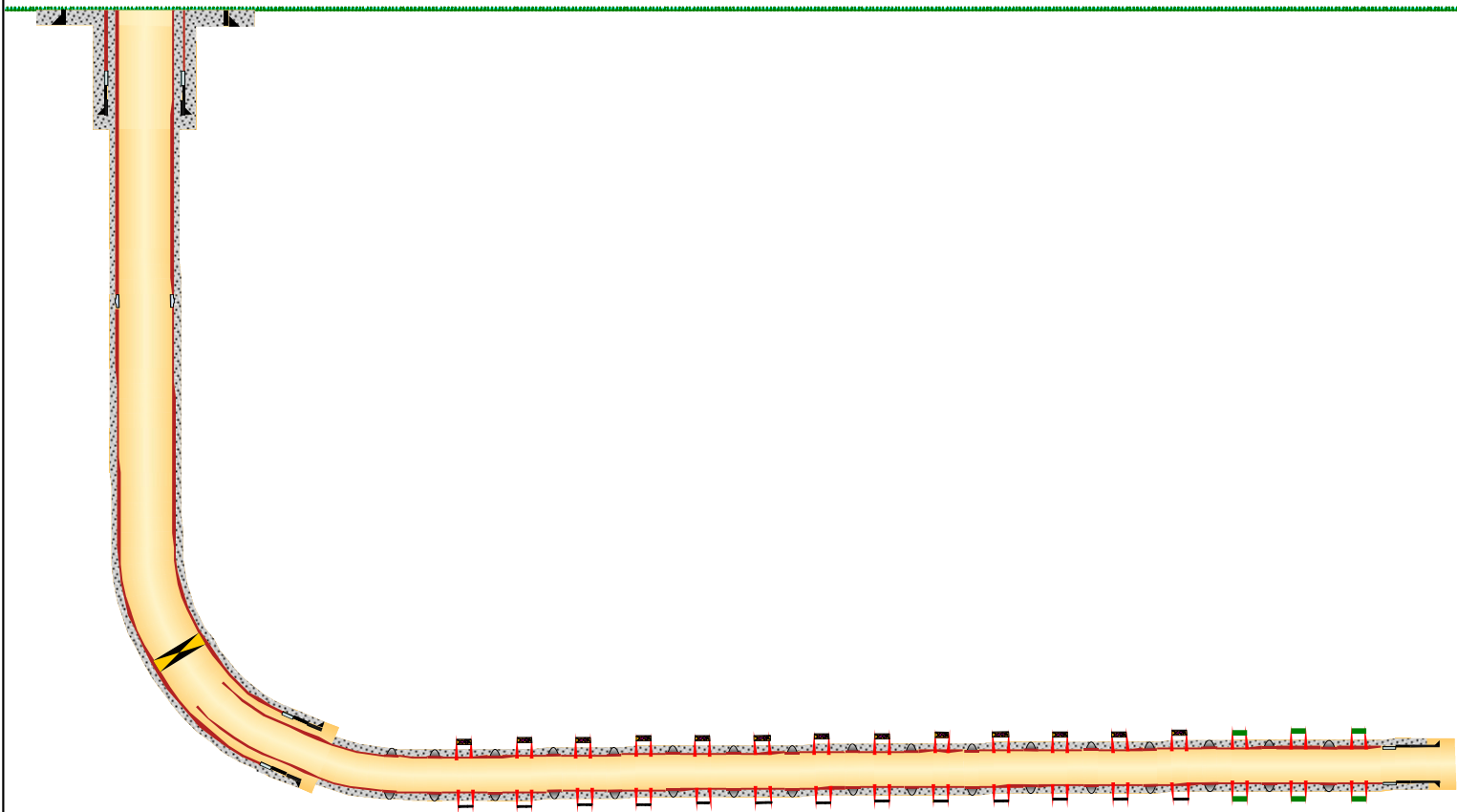
Directional Schematic and Survey Plot
