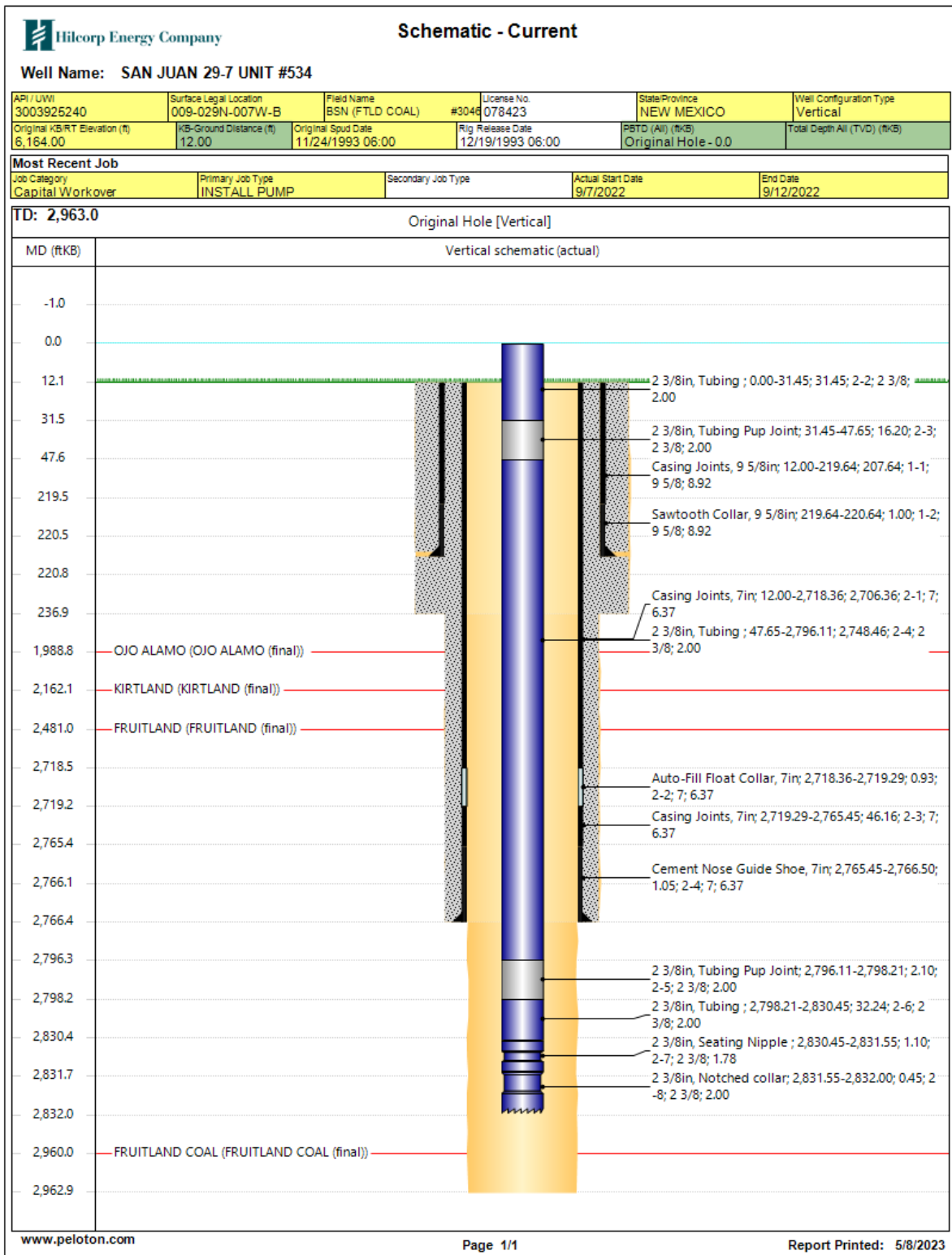
Drop-Off (uncemented) Liner Install

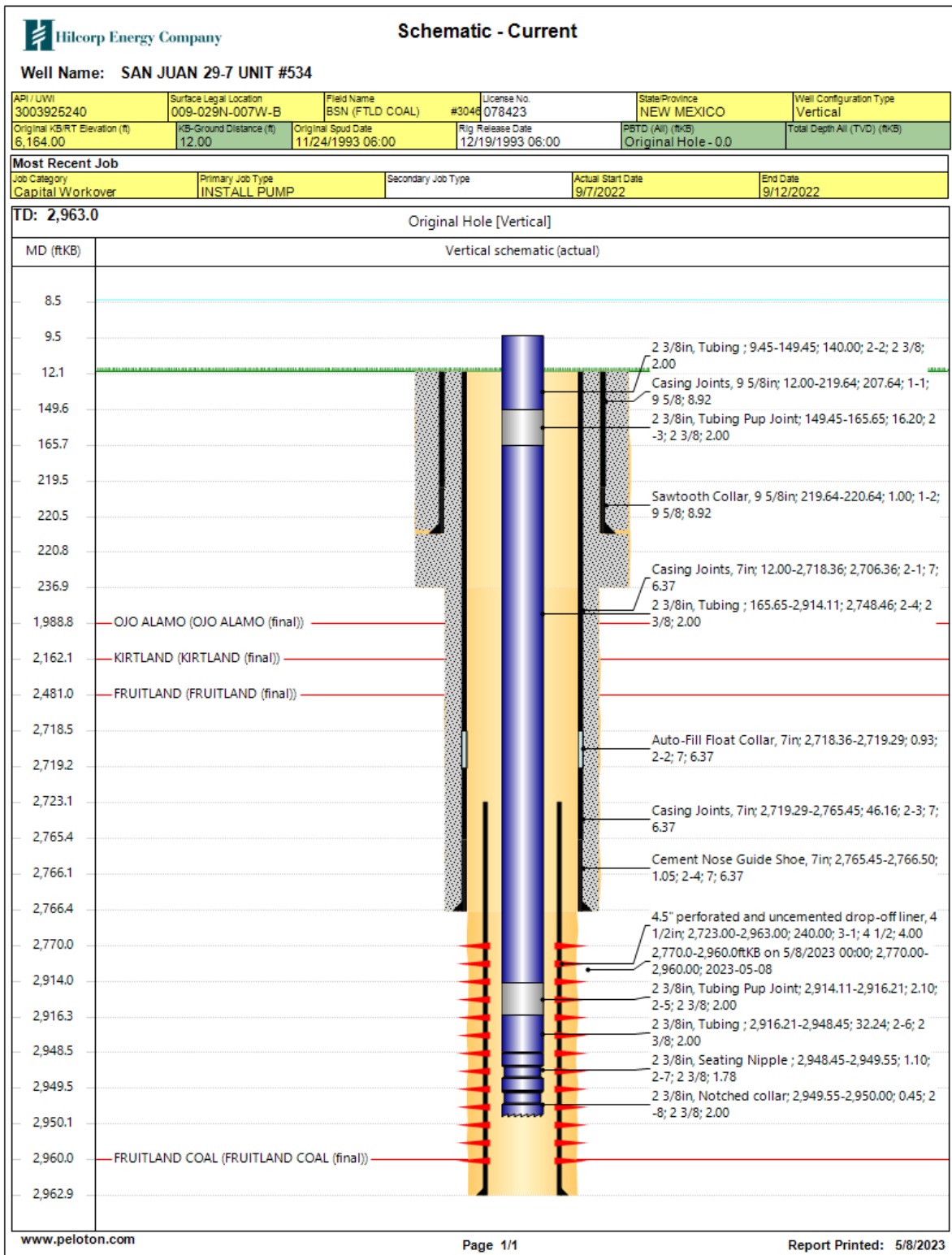
5/08/23

Well was cleaned out in 2022 and slickline has confirmed coal has subsided around end of tubing. Work will be performed to install drop-off, uncemented liner to allow coal to be produced without collapsing around the end of tubing and inhibiting dewatering.

Procedure:

1. MIRU PU and associated equipment. Kill well and NDWH.
2. NUBOP and unseat tubing, POOH with 2-3/8" string
3. Make up 3-7/8" bit on workstring and cleanout to plug back TD at 2963'
4. Roundtrip and swap to 6-1/4" bit (original hole size)
5. Cleanout to PBTD and circulate clean
6. POOH and lay down bit, PU 4-1/2" liner and run to bottom.
7. Shear setting tool and land drop off liner from 2963' (PBTD) to 2725'
8. POOH and lay down workstring
9. RU basing eline and perforate liner across coal from 2960' to 2770'
10. Run in hole with production tubing and circulate ID of 4.5" liner clean.
11. Land tubing at +/-2950'. NDBOP, NUWH, RTP and RDMO
