Matador is currently drilling Silver 403H and 504H wells with one rig on the Gavilon, Pony Express and Silver properties and requests this extension to enable it to drill these wells at or around the same time and then complete them and bring them onto production at the same time. Matador expects this co-development of the acreage to be the most efficient way to develop this acreage, thereby maximizing reserves and preventing waste.
