This extension is necessary as a result of prioritized development in the Wolfcamp formation to best service depletion, and thus delaying the development of the Bone Spring. Otherwise, the simultaneous development and initial production of the two formations would have exceeded infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water.

EOG's goal is to spud these wells by February 28, 2024.
