It has been necessary for EOG, as operator, to prioritize development in the upper Wolfcamp formation to best service depletion, and thus delay the development of the other targets. Accordingly, the extension is necessary for the permits to drill associated with the other targets. Otherwise, the simultaneous development of all prospective targets would exceed infrastructure capacities and potentially result in the need to flare gas and/or truck oil and water.
