This extension is necessary to allow EOG, as operator, adequate time to study and assess the communication between legacy producing wells in the Red Hills North Unit (3rd Bone Spring waterflood) and the surrounding formations. Accordingly, the development of the wells associated with these permits has been delayed.

EOG's goal is to spud these wells by January 31, 2024.
