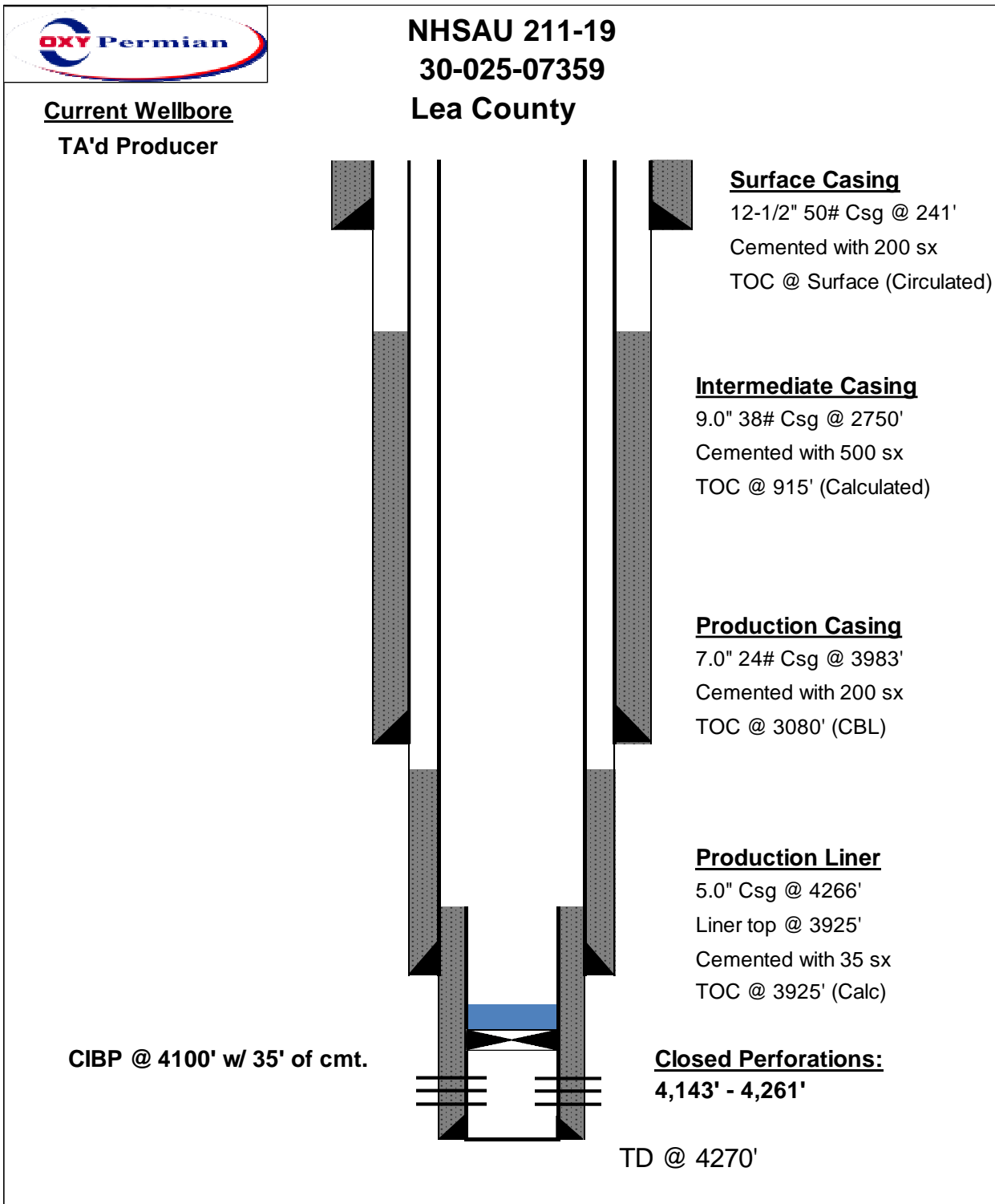

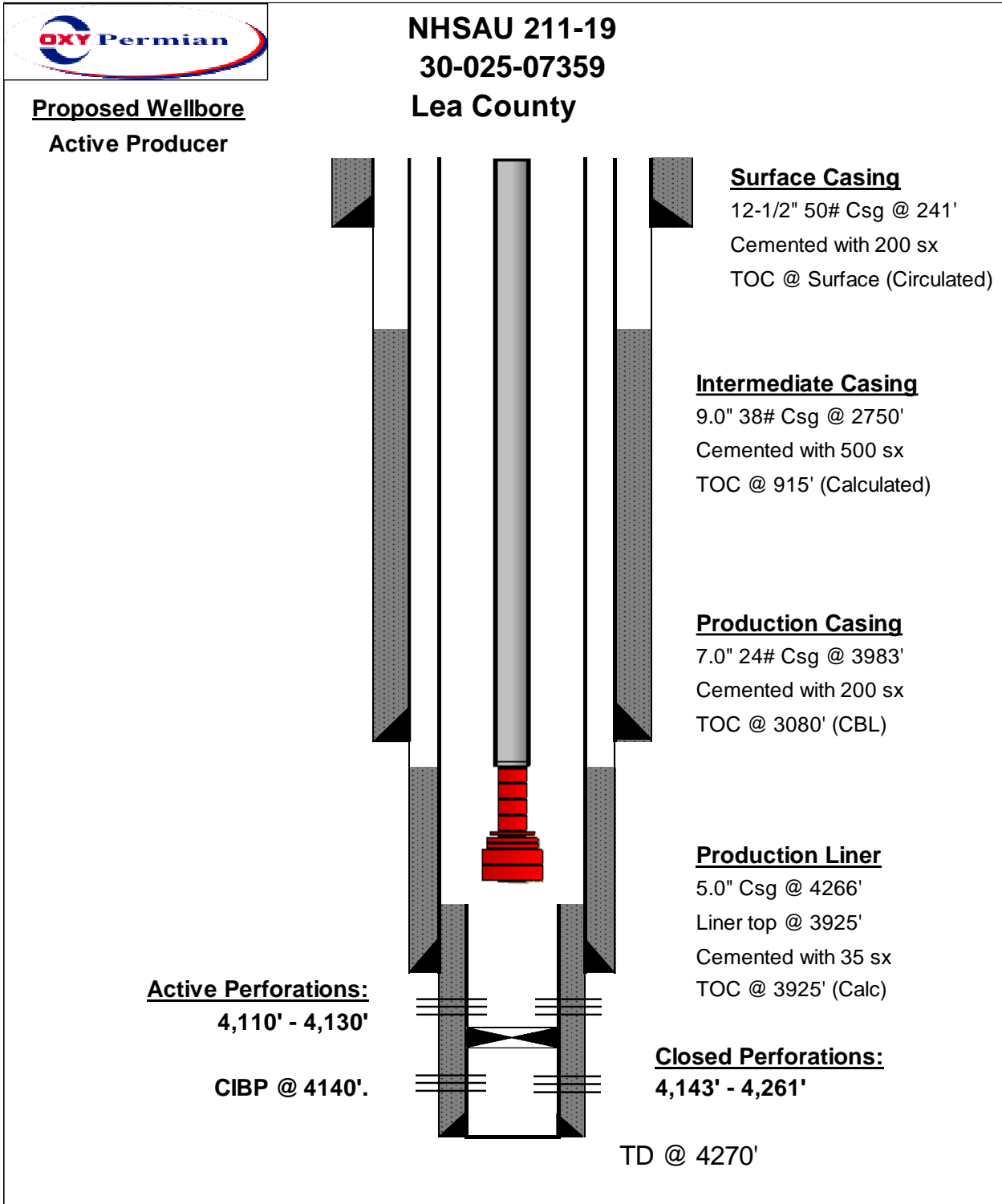

7. Drill out CIBP & Cleanout to PBTD @ 4263'
8. POOH w/ bit
9. RU WL
10. Set CIBP @ 4140'
11. Perforate casing from 4110'-4130'. RD WL.
12. RIH w/ RBP & packer. Acidize new perforations. POOH.
13. Run production equipment. Land ESP @ ~3900'.
14. RD PU
15. Return well to production
