It has been necessary for EOG to prioritize certain formations and avoid the simultaneous development and production of all formations as it would exceed infrastructure capacities and potentially resulting in the need to flare gas and truck produced oil and water. Additionally, the development and utilization of these permits has been staggered in order to assess the reservoir quality for the best possible multi-zone development.

EOG's goal is to spud these wells by March 31, 2024.
