Primary development in the Wolfcamp delayed development of the Leonard and Bone Spring. The simultaneous development and production of all formations would exceed infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water. Additionally, recent well results suggest that optimal development of these formations to harvest the most minerals and reduce waste will require supplemental permits.

We plan to drill these wells on 7/1/24.
