

PARCEL DESCRIPTION

A STRIP OF LAND ON A PARCEL OF LAND OWNED BY THE BUREAU OF LAND MANAGEMENT AND IS LOCATED IN A PART OF THE W 1/2 OF SECTION 9, TOWNSHIP 20 SOUTH, RANGE 29 EAST OF THE NEW MEXICO PRINCIPAL MERIDIAN, COUNTY OF EDDY, STATE OF NEW MEXICO;

A 30 FEET WIDE PERMANENT EASEMENT, BEING 15 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

CENTERLINE DESCRIPTION

COMMENCING AT THE W 1/4 CORNER OF SAID SECTION 9, (AS MONUMENTED BY A FOUND 1" IRON PIPE W/ WASHER PS 22896), FROM WHICH THE SW CORNER OF SAID SECTION 9, (AS MONUMENTED BY A FOUND GLO BRASS CAP DATED 1916), BEARS S 00°06'01" E, A DISTANCE OF 2,639.98 FEET, FORMING THE **BASIS OF BEARINGS** USED IN THIS DESCRIPTION;

THENCE, N 52°47'28" E, A DISTANCE OF 1,106.79 FEET TO THE **POINT OF BEGINNING**;

THENCE, ALONG SAID CENTERLINE THE FOLLOWING ELEVEN (11) COURSES:

- 1) S 01°39'38" E, A DISTANCE OF 206.89 FEET;
