Procedure Description: BLM Bond NMB001079 Surety Bond No.: RLB0015172 1. Cement bond log on 7-5/8" liner completed on 8/27/23 prior to drilling 6-1/2" open hole (cement bond log attached). 2. Ran open hole logs from TD to above top of Devonian that will allow for evaluating injection zone. 3. Based upon log analysis, perforate particular zones of interest within Devonian open hole injection zone. 4. Utilize surface pressure and/or fluid level with known wellbore fluid to calculate static bottom hole pressure. 5. Set permanent packer equipped with pump out plug within 100' of 7-5/8" casing shoe, just above open hole section. 6. Run seal assembly and 5-1/2" x 7" fiberglass lined injection string, circulate packer fluid, land tubing in packer polished bore receptacle. 7. Perform mechanical integrity test to 500 psi for 30 minutes on casing-tubing annulus, to be witnessed by NMOCD and/or BLM representative.
