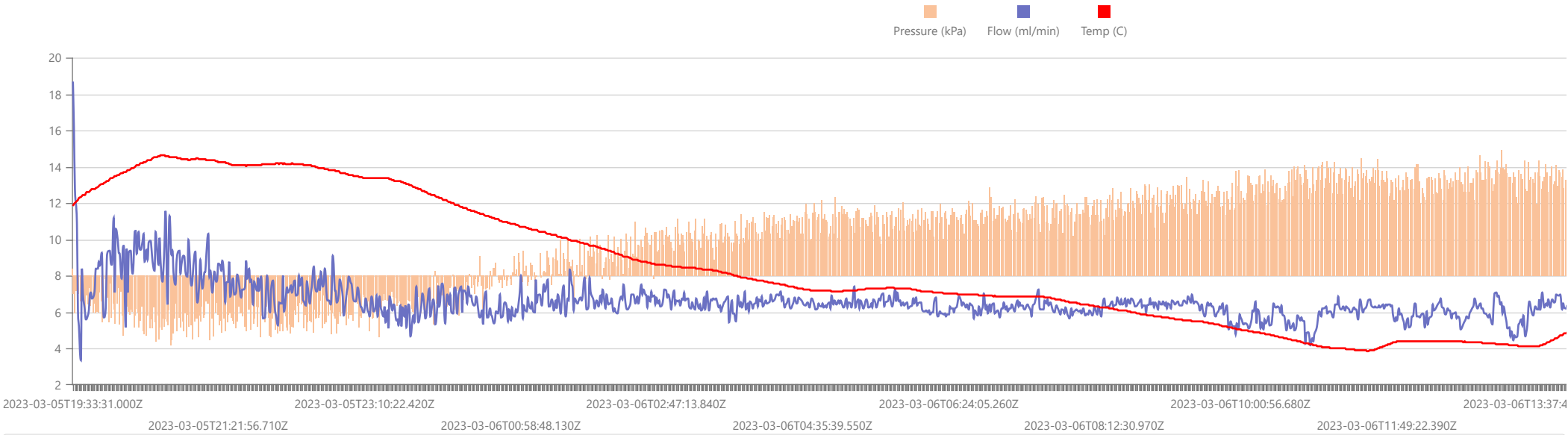

Methane Calculation: 717 grams CH4 per cubic meter (717 g/m³ x 6.4268 m³/day = 4608.02 g/day total /24 = 192.00 g/hour x 0.1141 (methane concentration) = **21.91 g/hour CH4**). **Methane, gas** weighs 0.000717 *gram per cubic centimeter* or 0.717 *kilgram per cubic meter*, i.e. density of *methane, gas* is equal to 0.717 kg/m³; at 0°C (32°F or 273.15K) at standard atmospheric pressure. In imperial or US customary measurement system, the density is equal to 0.0448 *pound per cubic foot* [lb/ft³], or 0.0004144 *ounce per cubic inch* [oz/inch³].

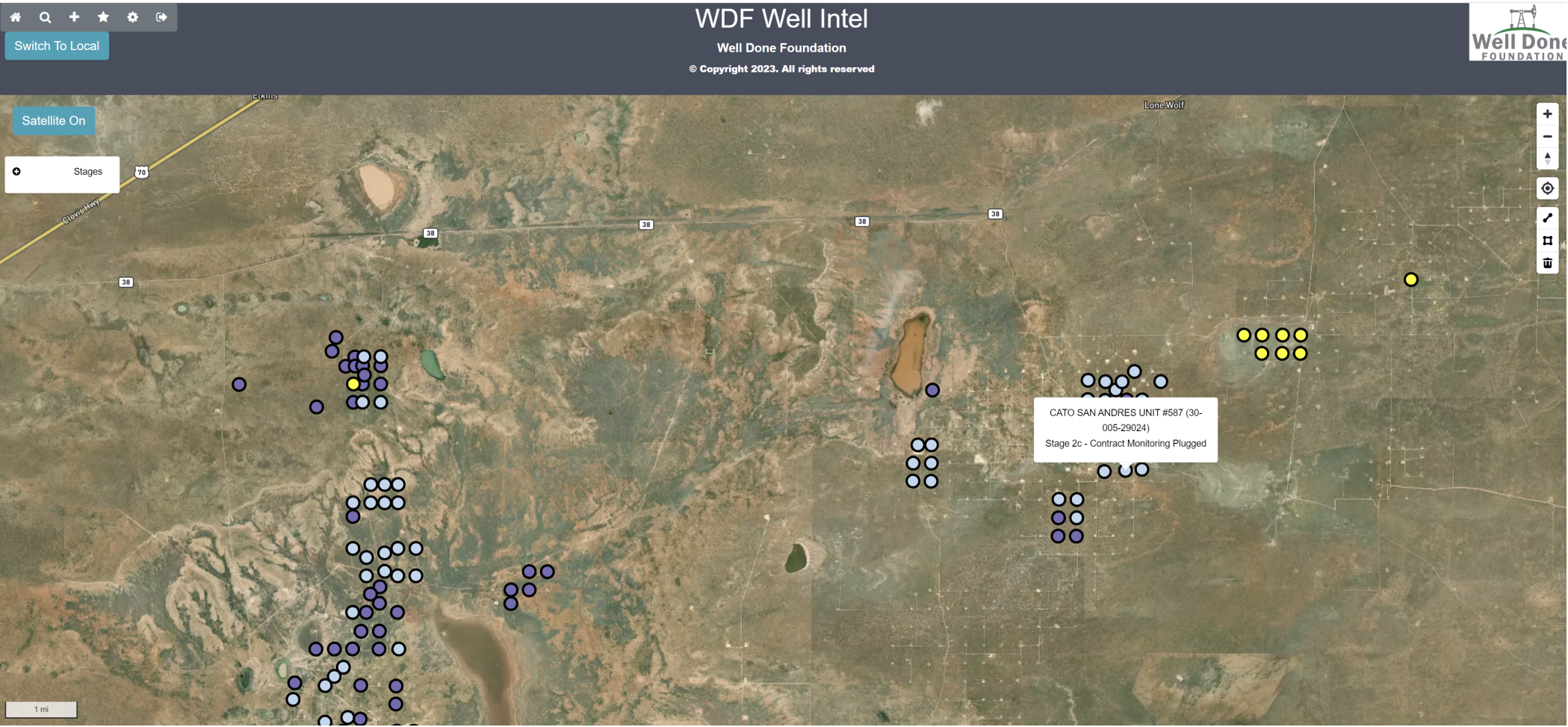
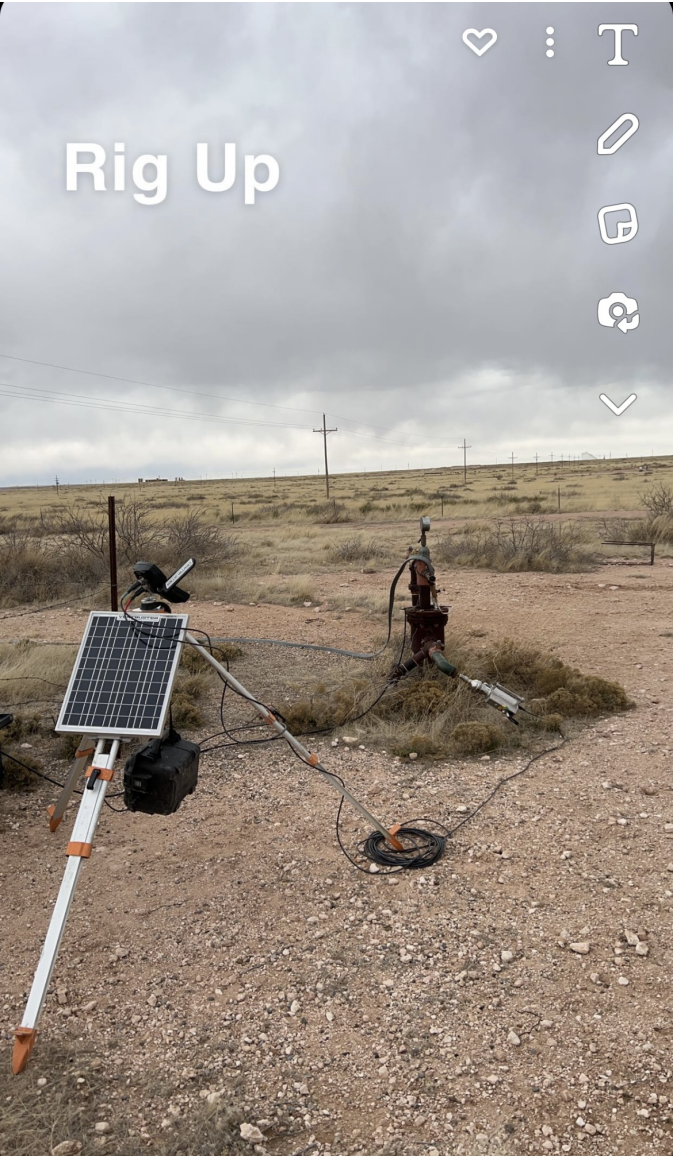
